John,

I included our electrical team on this email as there were some electrical items in the WP#2. We reviewed the work package and have the following comments:

1. The Work Package does not include submittal data for review, our review of WP-2 is limited to general comments relative to where we are at in the design process. We would need actual submittals for all M&E equipment to review for compliance with drawings and specifications.

- 2. There are no lead times for electrical equipment shown or listed in the work package, just a bid from Graybar for some of the electrical equipment with standard bid verbiage. The electrical quote only appears to cover the electrical service equipment and what appears to be some of the panelboards, but it is hard to tell as Graybar has lump sums for some Millbank and Square D equipment. It's not clear if the bid includes the stepdown transformer. The only thing in the quote about lead times is a statement that the estimated delivery is "to be determined".
- 3. Graybar's bid does not appear to include any of the lighting, conduit, wire, boxes, wiring devices, etc.
- 4. Underfloor waste piping sizes and lengths have changed from 65% set, quantities listed in quote do not reflect current plans. We recommend contractor review updated underfloor piping plan in Package No. 2 Footing, Foundation and Exterior Envelope prior to ordering underfloor piping.
- 5. CUH and UH quantities do not match number of units shown on mechanical plans.
- 6. Pump selections for CP-1A/1B are different then specified models. We understand the alternate pumps are being proposed for lead time, we will need to review pump capacity to determine if they will meet design requirements.
- 7. The Acorn plumbing fixtures have long lead times, but appear crossed out on the estimate.
- 8. The quote includes two options for RTUs, it is not clear what is being provided.
- 9. They quote includes alternate equip models for grease interceptors and hot water storage tank. We would need to review submittal data to confirm they are equivalent products to models specified.

Let us know if you want to discuss any of the items noted.
