John-

There is obviously a potential savings when we go out to bid, but we chose pre-construction subs who have typically been competitive in the past so I don't expect major changes.

In running the numbers, we have about \$3M in MEP subcontractors. If we realized a savings of 10% (which if there is a larger delta than that we should be concerned anyway) we would see a savings of \$300,000. So yes, might be some but not enough to get down to \$10 M budget.

To re-iterate your point as well, with the nature of this project, I don't see a lot of significant reduction on this project to get down to \$10M, we are very bare bones as it is.

Saxton,

I see a real problem cropping up. Your approved budget (\$10M as I recall) does not meet with the Construction Cost Estimate. We are moving quickly now with work-packages and permitting packages, Fill and Grade & Footing and Foundations (the F&F starts the ball rolling with the approval through structural permit review of the structure from Sprung and the F&F).

In my professional opinion I don't see any significant reductions; certainly not at the magnitude of the delta. Please coordinate fill us in on how you (and your leadership) plan to fill the gap. We are hurling towards a 95% deadline by the end of this month and I'm very concerned.
