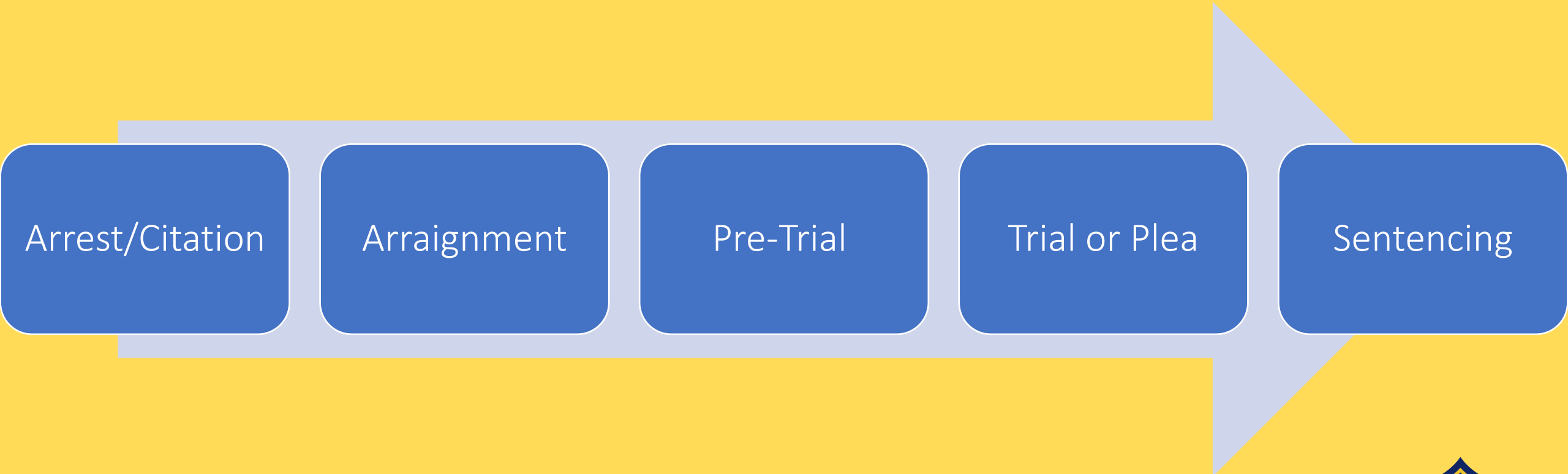

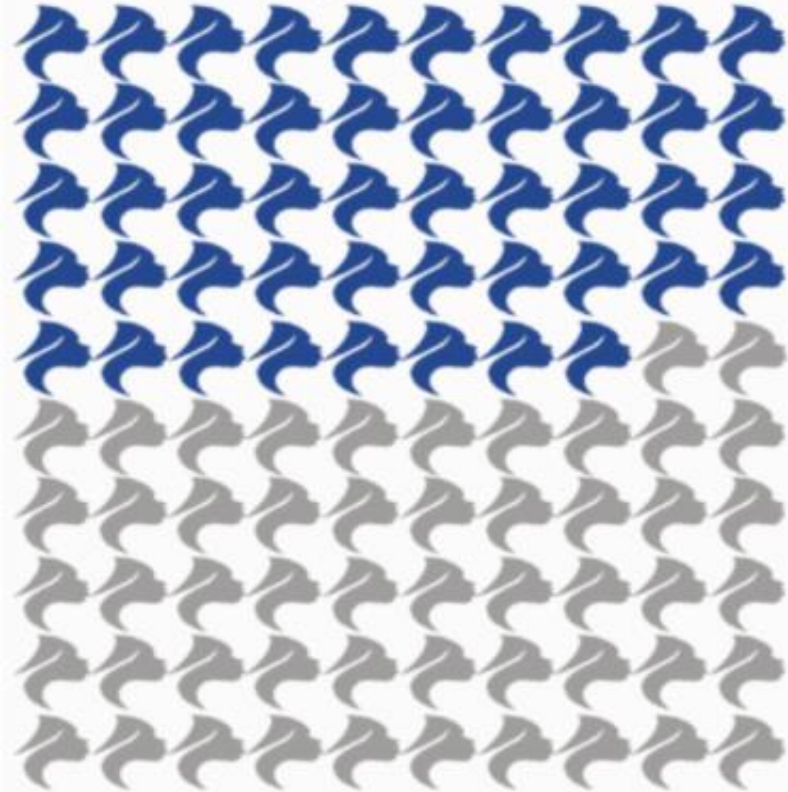

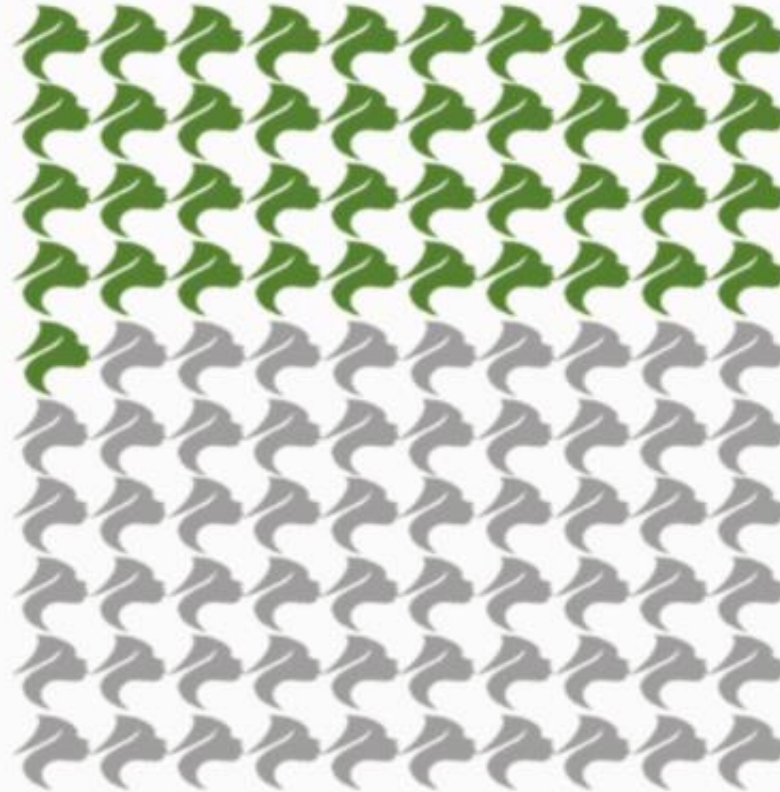

Out of every 100 adult women who reside in the State of Alaska:

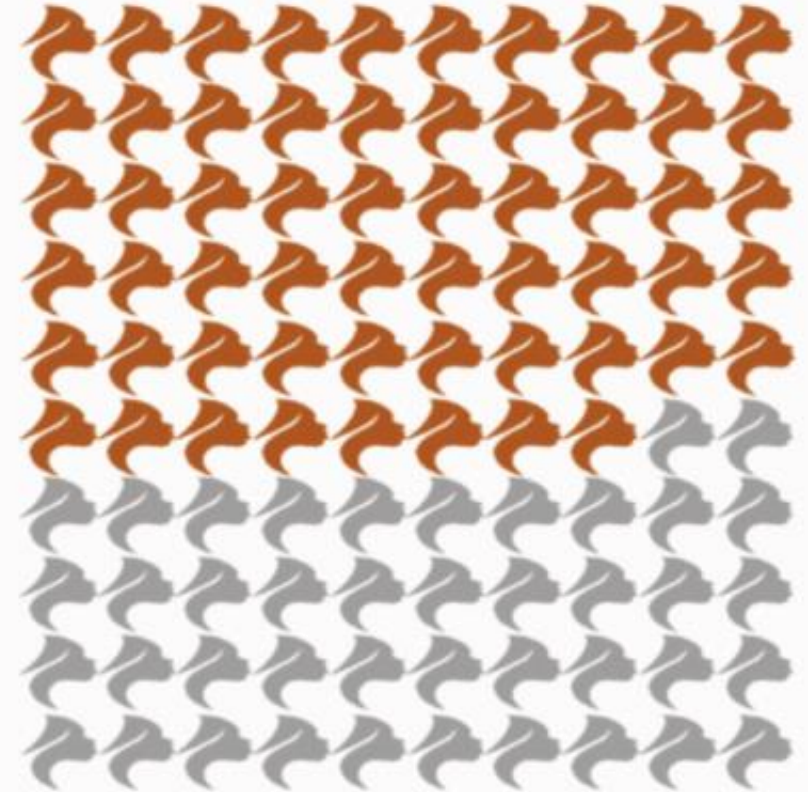
48 experienced intimate partner violence



41 experienced sexual violence

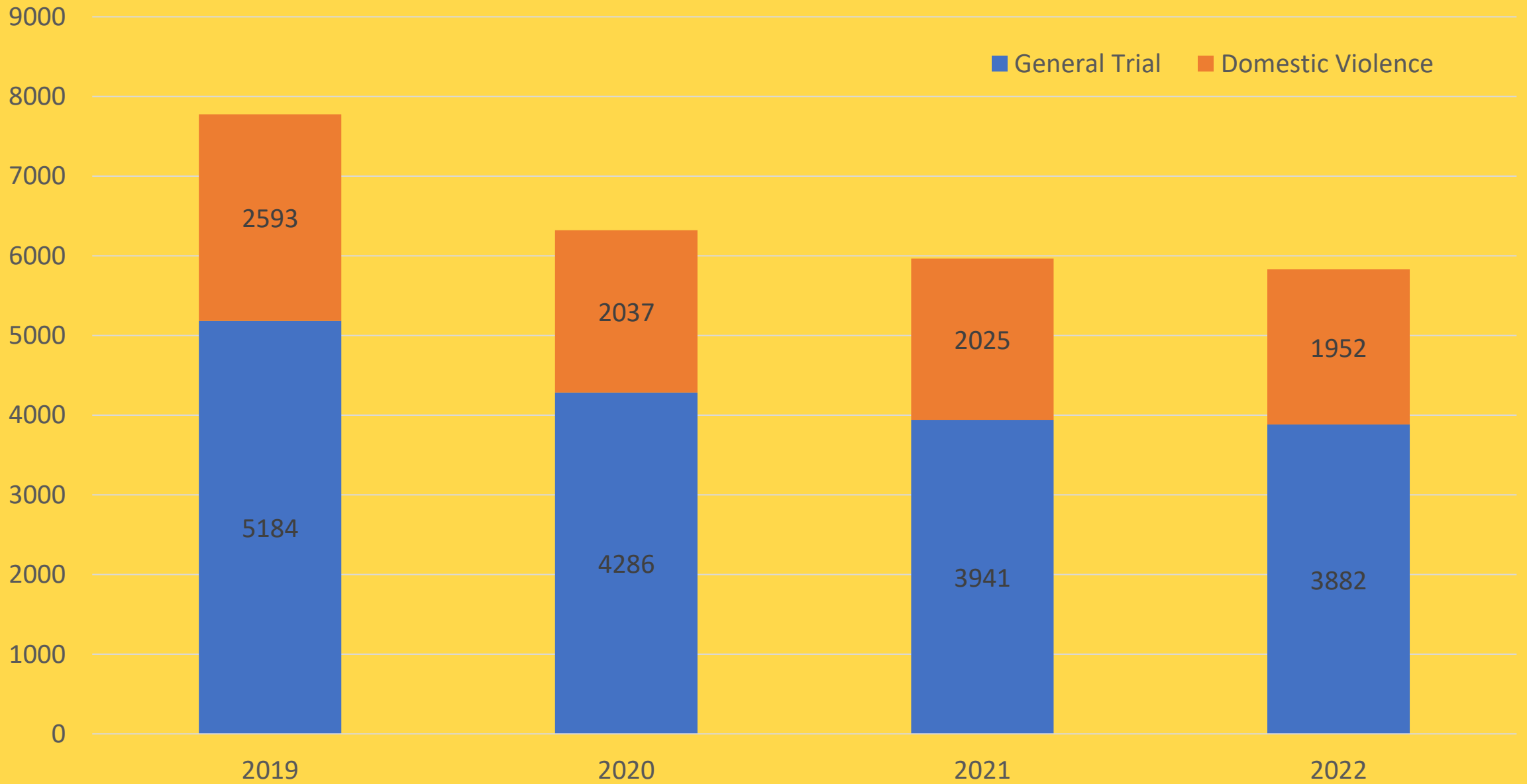


58 experienced intimate partner violence, sexual violence, or both

# Facts about MOA Prosecution

- Largest prosecution unit in Alaska focused solely on Domestic Violence
- Therapeutic Courts – Veterans Court, Mental Health (CRP) Court, Wellness Court
- Rehabilitation Focus
- Victims of crimes personally notified by phone, mail, or text (3000 calls per year)
- Bail conditions provided to APD every day
- Vast majority of cases are against contracted indigent defense counsel
