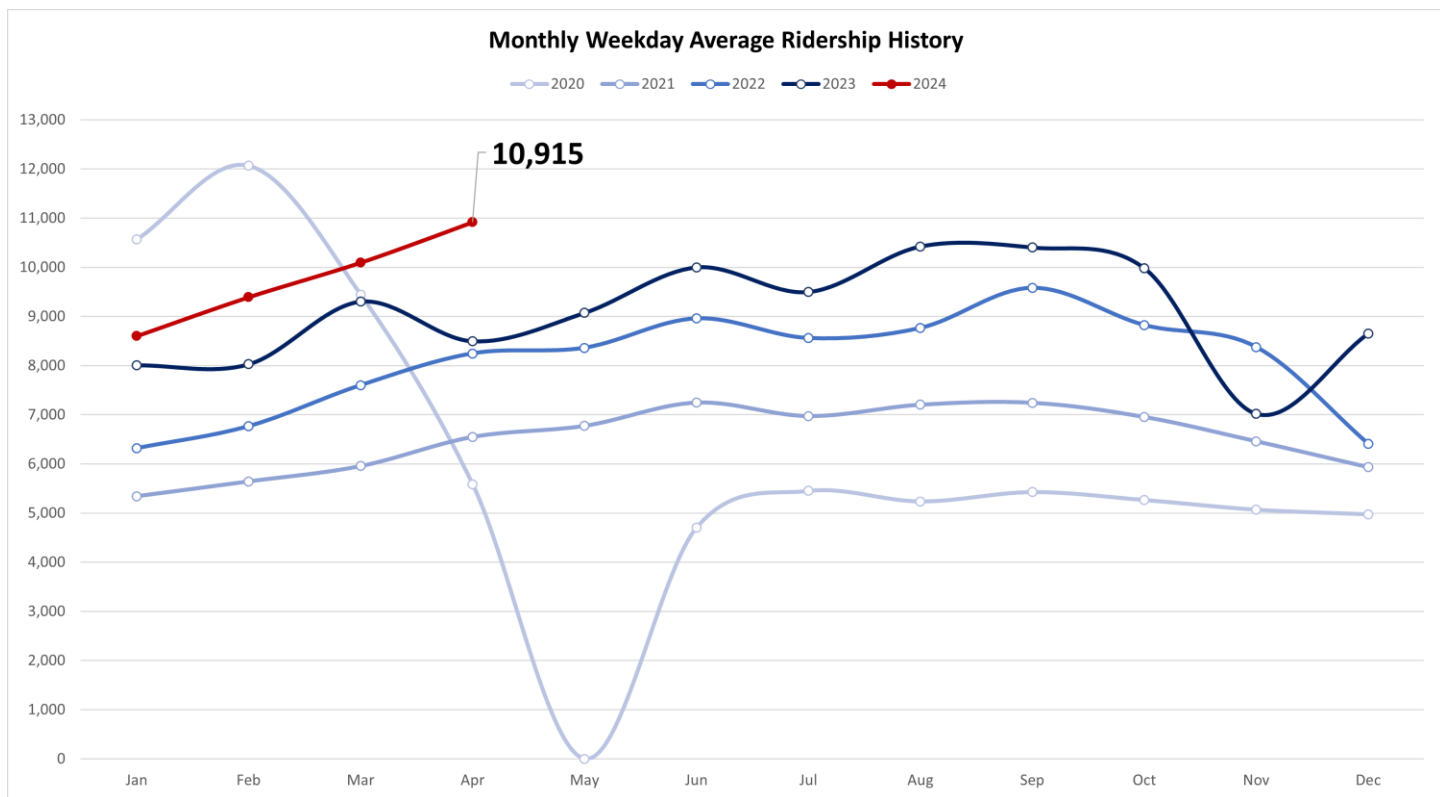

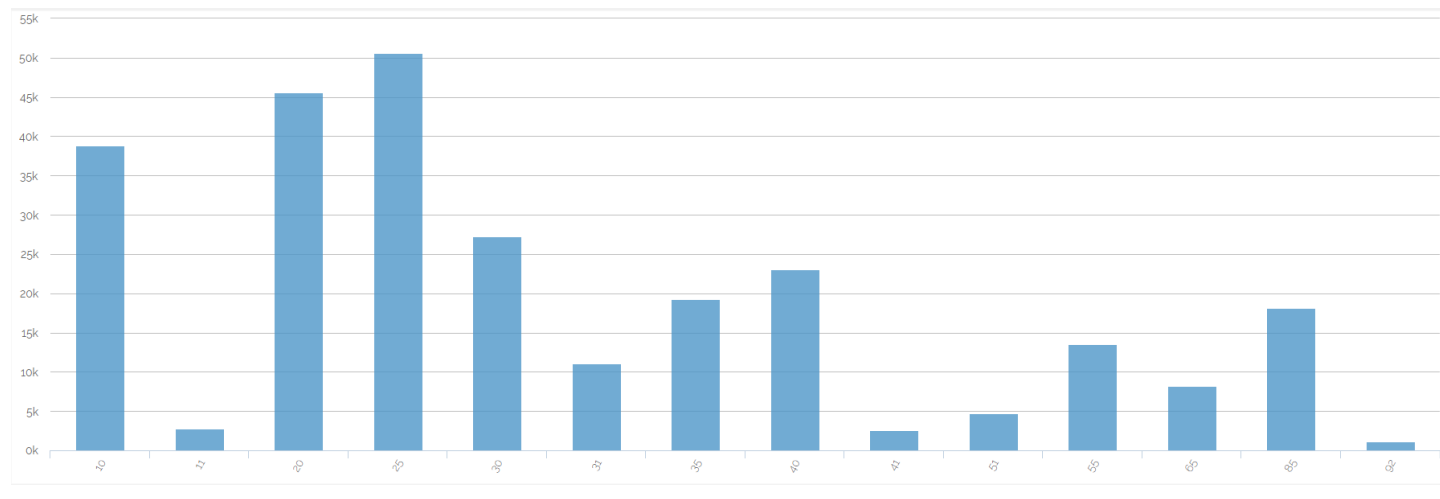

People Mover PTAB Ridership Report

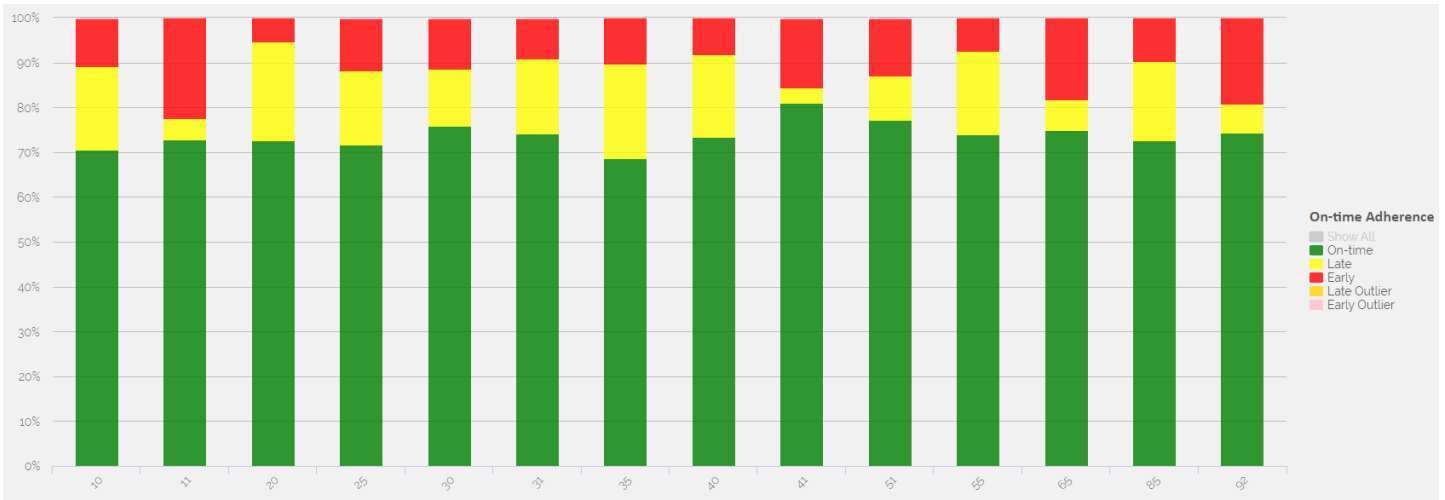
All charts display data from April 1-30, 2024.



In April 2024, average weekday ridership was 10,915 an 28.4% increase compared to April 2023's average of 8,496 riders.

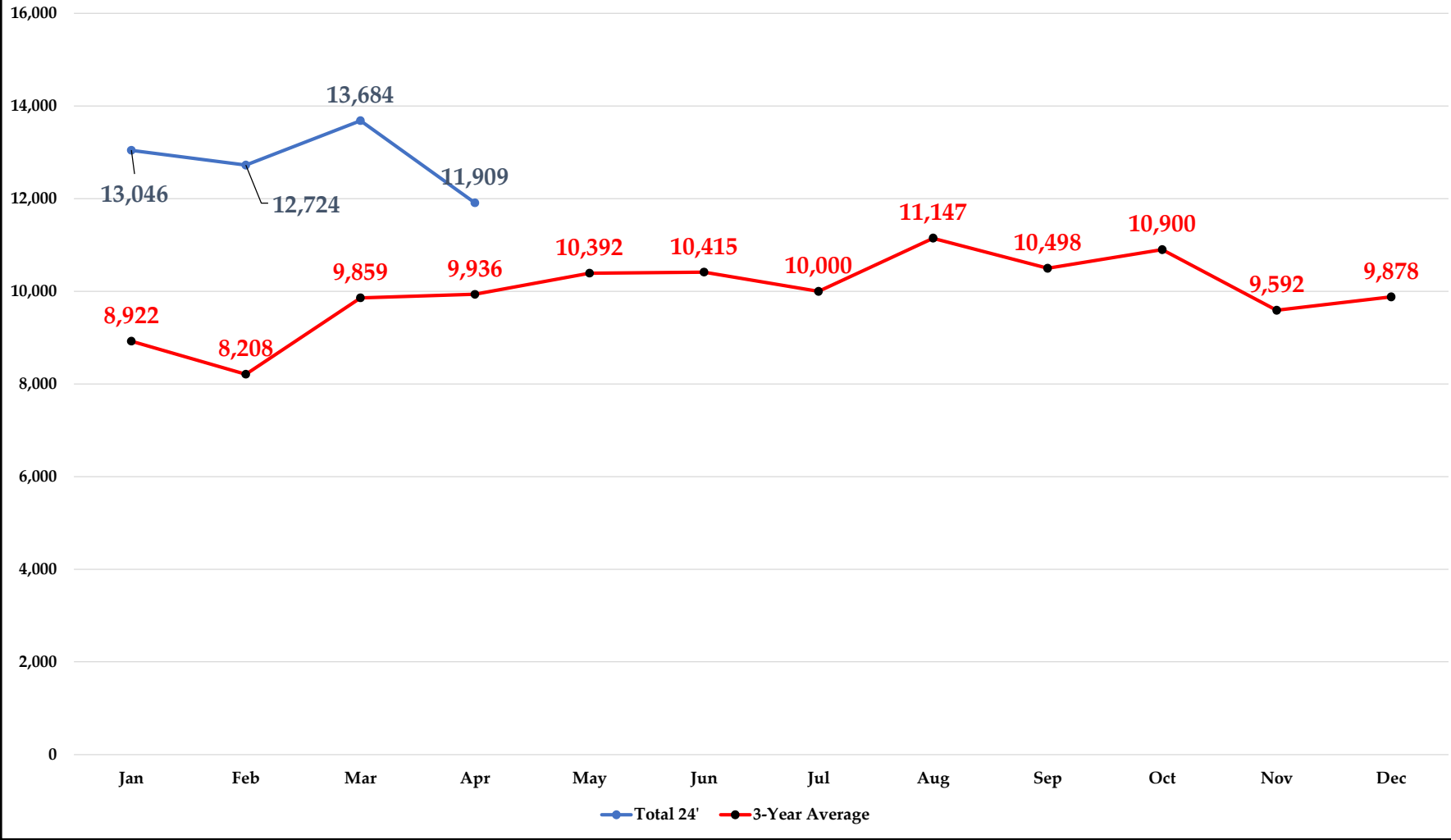


Route 25 had the highest total ridership, followed by routes 20 and 10, respectively.

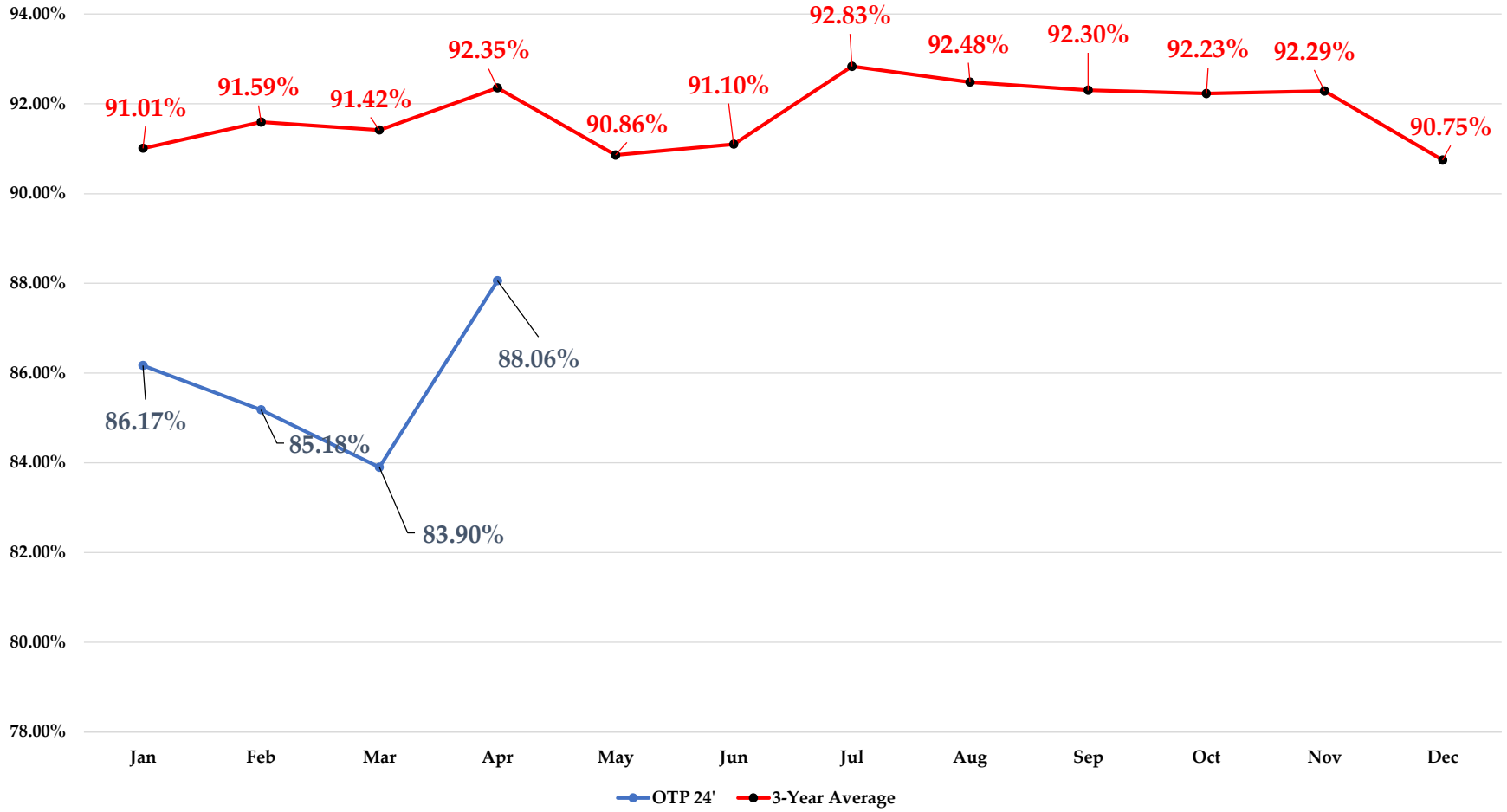


Overall system on-time performance was 73%. Route 41 had the highest on-time percentage at 79%.

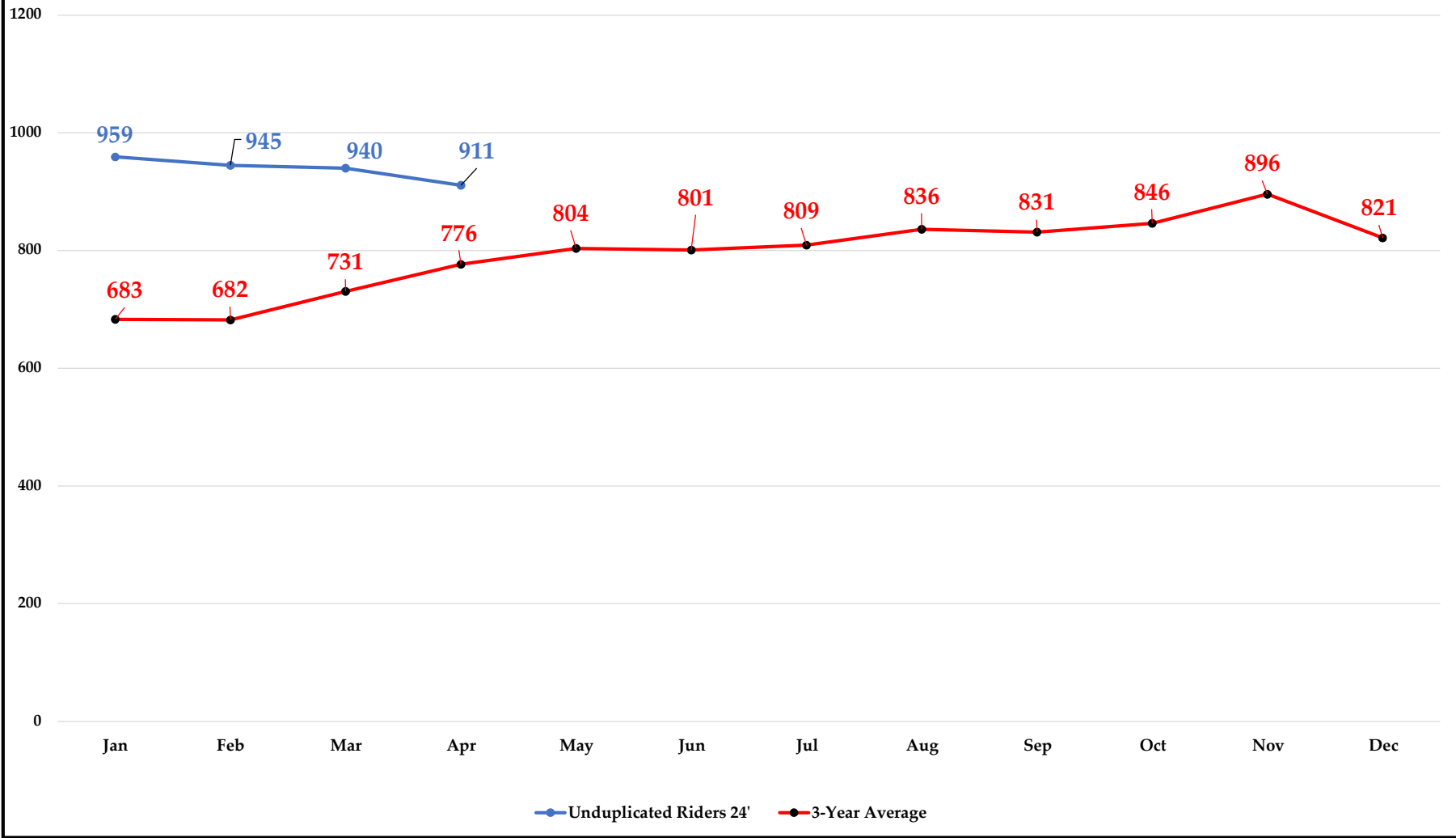
AnchorRIDES 2024 Ridership
