### General Information

- ▶ **Only use this form** to receive your ballot at a temporary mailing address.
- ▶ **Apply early to receive your ballot at a temporary mailing address.** Please complete your application by **March 1, 2018** to timely receive your ballot. You may submit an application after March 1, 2018 but it must be received no later than March 27, 2018.
- ▶ **Hand-deliver, mail, fax, or scan and email completed application to MOA Elections.**

- ▶ **When completing your application be sure to:**
  - **Type or print legibly and use dark ink if you complete the application by hand.**
  - **Provide your complete Municipality of Anchorage residence address.** Your application *will not be processed* if the residence address is left blank or incomplete, or if you submit a PO Box, PSC Box, commercial address, or mail stop.
    - **If your residence does not have an assigned number,** indicate exactly where you live, such as the subdivision name, lot, and block; highway name and milepost; or trailer park name and space number.
    - **If you wish to vote while temporarily residing outside of Anchorage,** you must still provide your Anchorage residence address.
    - **If your Anchorage residence address has changed,** provide your new address on the application.
  - **Provide a telephone number** where we can contact you.
  - **Provide the temporary mailing address** where you want to receive your ballot materials.
  - **Provide at least one identifier** such as voter number, last four digits of your social security number, or date of birth. This information is kept confidential.
  - **Print** a copy of your completed application if you are completing it electronically.
  - **Write your signature and date. An electronic signature is not acceptable.**
- ▶ All ballots with temporary addresses will be mailed beginning the week of March 13, 2018. Absentee ballots are mailed in the order that applications are received. **If you have not received your ballot by Monday, April 2, 2018, call 907-243-VOTE (8683) before 5:00 p.m. AKDT to obtain an electronic ballot.**
- ▶ **Return your ballot as soon as possible.** Voted ballots must be postmarked no later than Election Day, April 3, 2018.
