General Information

- ▶ **Apply early to receive your ballot at an email address.** Applications to receive a ballot at an email address must be received in the Municipal Clerk's Office by 5:00 p.m. AKDT on March 27, 2018. Applications received after 5:00 p.m. on March 27, 2018 will be processed subject to availability of staff and resources until 5:00 p.m. AKDT on **Monday, April 2, 2018.**
- ▶ **Hand-deliver, mail, fax, or scan and email completed application to MOA Elections.**

- ▶ **When completing your application be sure to:**
 - **Type or print legibly and use dark ink if you complete the application by hand.**
 - **Provide your complete Municipality of Anchorage residence address.** Your application *will not be processed* if the residence address is left blank or incomplete, or if you submit a PO Box, PSC Box, commercial address, or mail stop.
 - **If your residence does not have an assigned number,** indicate exactly where you live, such as the subdivision name, lot, and block; highway name and milepost; or trailer park name and space number.
 - **If you wish to vote while temporarily residing outside of Anchorage,** you must still provide your Anchorage residence address.
 - **If your Anchorage residence address has changed,** provide your new address on the application.
 - **Provide a telephone number** where we can contact you.
 - **Provide the email address** where you want to receive your ballot package.
 - **Provide at least one identifier** such as voter number, last four digits of your social security number, or date of birth. This information is kept confidential.
 - **Print** a copy of your application if you are completing it electronically.
 - **Write your signature and date. An electronic signature is not acceptable.**
- ▶ Ballot will be emailed in the order that applications are received beginning the week of March 13, 2018. **If you do not receive your ballot by Monday, April 2, 2018, call 907-243-VOTE (8683) before 5:00 p.m. AKDT to obtain a duplicate ballot.**
- ▶ **Return your ballot as soon as possible.** Voted ballots must be received by 8:00 p.m. on Election Day, Tuesday, April 3, 2018.
