## Application to Vote by Email

### General Information

- ▶ **Apply early to receive your ballot at an email address.** The application must be received by July 31, 2018 at 5:00 pm AKDT. Applications will be processed as time allows after this deadline, through August 6<sup>th</sup> at 5:00 pm AKDT.
- ▶ **All ballots will be sent out beginning the week of July 17, 2018.** Applications received by July 6<sup>th</sup>, will be emailed on July 17<sup>th</sup>. Applications may be submitted between July 7<sup>th</sup> and August 6<sup>th</sup> and will be emailed within two business days of receiving your application.
  - **If you have not received your ballot within 2 days of receipt,** call 907-243-VOTE (8683) or email [ElectronicVoting@muni.org](mailto:ElectronicVoting@muni.org) before 5:00 PM on Monday, August 6, 2018 to obtain a duplicate ballot.
- ▶ **If you will not be available at an email address between July 17<sup>th</sup> and August 3<sup>rd</sup>,** please email [Elections@muni.org](mailto:Elections@muni.org) or call 907-243-VOTE (8683) as soon as possible, to learn about other options for you to vote. Applications to Vote at a Temporary Address and Vote by Fax are available at [muni.org/elections](http://muni.org/elections).
- ▶ **Return your ballot as soon as possible.** Voted ballots must be received by **8:00 PM AKDT on Election Day, Tuesday, August 7, 2018.**
- ▶ **Verify your State of Alaska Voter Registration online.** Go to [myvoterinformation.alaska.gov](http://myvoterinformation.alaska.gov) to check your current voter registration information. If necessary, this information can be updated online at [voterregistration.alaska.gov](http://voterregistration.alaska.gov). The deadline to update this information for the Tuesday, August 7, 2018 Special Municipal Election is Sunday, July 8, 2018.
- ▶ **Hand-deliver, mail, fax, or email completed application to MOA Elections or the Municipal Clerk's Office.**

- ▶ **When completing your application be sure to:**
  - **Type or print legibly and use dark ink if you complete the application by hand.**
  - **Provide your complete Municipality of Anchorage residence address.** Your application *will not be processed* if the residence address is left blank, incomplete, or if you submit a PO Box, PSC Box, commercial address, or mail stop.
    - **If your Anchorage residence address has changed,** provide your new address on the application. This will **not** update your voter registration.
  - **Provide a telephone number and/or email address** so we can contact you, if necessary.
  - **Provide the email address** where you want to receive your ballot package.
  - **Provide at least one identifier** such as voter number, last four digits of your social security number, or date of birth. This information is kept confidential.
  - **Write your signature and date.** **A computer generated signature is not acceptable.**
