## **Absentee By-Mail Application General Information**

- ▶ All absentee by-mail applications must be received in the Municipal Clerk's office **AT LEAST 7 DAYS** prior to the election. **APPLY EARLY TO RECEIVE YOUR BALLOT IN TIME. VOTED BALLOTS MUST BE POSTMARKED NO LATER THAN ELECTION DAY. You may FAX your application to us at 343-4313.**

- ▶ Print clearly. Use dark ink.

- ▶ **You must provide a complete residence address in the Municipality of Anchorage.** *Your application will not be processed if the residence is blank or if you provide PO Box, PSC Box, Commercial Address or Mail Stop Address.*

If your residence address has been assigned a street number, provide that number. If not, indicate exactly where you live such as subdivision name with lot and block, highway name and milepost number or trailer park name and space number.

If you are temporarily outside of Alaska, in accordance to State law you may maintain your residence as it appears on your current voter registration record. If you provide a new address, it must be within the Municipality of Anchorage.

- ▶ Provide a complete ballot mailing address of where you wish your ballot to be mailed. Mailing of ballots will begin no later than 10 days before the Regular Election. Ballots are mailed beginning the same week Absentee locations open and are mailed in the order received.
- ▶ You must provide at least one identifier such as voter number, social security number, and date of birth or birth place. This information is maintained as confidential information.
- ▶ Indicate the election you wish to receive a by-mail ballot, sign and date your application. You must apply for each election separately.
