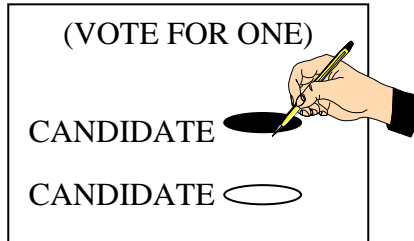

BY-FAX BALLOT INSTRUCTIONS

These are instructions for your official faxed ballot. Please read carefully.

1. **By using electronic transmission to return your voted ballot you are voluntarily waiving a portion of your right to a secret ballot and assuming the risk that a faulty transmission may occur.**
2. Your ballot must be voted, witnessed and faxed **no later than 8:00 p.m. Alaska Time on Election Day April 3, 2012.** Ballots that are returned by mail must be postmarked on or before Election Day. The earliest dated and timed version of a voted ballot or any other voting material received by the Election Official will be accepted. All other versions of a voted ballot or any other voting material will be rejected.
3. **Completely fill in the ovals next to your choices.** Use a black pen or No. 2 pencil to mark your ballot. To vote for a write in candidate you must write the candidate's name as well as fill in the corresponding oval.



4. After you have voted the ballot, complete all the information requested on the Voter Certification Form. **THIS INFORMATION IS REQUIRED BY LAW. FAILURE TO COMPLETE THE REQUIRED INFORMATION MAY CAUSE YOUR BALLOT NOT TO BE COUNTED.**
It is mandatory that you provide at least one of the following identifiers: voter number, social security number, or date of birth.
5. Your signature must be properly witnessed. A witness is attesting that he/she knows who you are and that you have signed the certification in his/her presence.
Two witnessing options are available:

Option I: Seek assistance from an official authorized to administer an oath (a justice, judge or magistrate of the court, a clerk or deputy clerk of the court, notary public, election official, or commissioned officer).
--OR--
Option II: Have your signature witnessed by one person over the age of 18.
6. Fax your Voter Certification Form and both Ballot pages back to the dedicated FAX # 907-249-7999. Your ballot must be **RECEIVED no later than Election Day, 8:00pm Tuesday, April 3, 2012.**
