NOMINATIONS OPEN NOTICE OF VACANCIES

Notice is hereby given that the following offices will be filled at the regular election of APRIL 6, 2010, and nominations for same will be opened JANUARY 29, 2010 and will close FEBRUARY 12, 2010, 5:00 p.m. Candidate filing forms are online at www.muni.org/elections Candidates link. Forms may also be picked up in the Office of the Municipal Clerk, City Hall, 632 W. 6th Avenue, Room 250.

Candidates' names will appear in random, alphabetical order on the ballot for the 2010 Regular Municipal Election. The public is invited to observe a drawing for the random, alphabetical order on JANUARY 28, 2010 at 1:00 p.m. in City Hall, Room 250. The process is in accordance with State and Municipal law.

A candidate elected April 6, 2010 will be elected to a three-year term expiring upon certification of the April, 2013 election unless otherwise noted.

Section 2 - Seat A Eagle River..... One member to be elected. A three-year term.
Section 3 - Seat D West Anchorage One member to be elected. A three-year term.
Section 4 - Seat F Midtown Anchorage..... One member to be elected. A three-year term.

A candidate for one of the above seats must be a qualified voter of Anchorage and of the State of Alaska and shall be a resident of the section from which he/she seeks election for at least one (1) year immediately preceding the election. Election is by Assembly section.

Seat B One member to be elected. A three-year term.

A candidate for one of the above seats must be a qualified voter of Anchorage and of the State of Alaska. Election is area-wide.

BEAR VALLEY LIMITED ROAD SERVICE AREA BOARD OF SUPERVISORS

Seat A..... One member to be elected. A three-year term with one year remaining
Seat B One member to be elected. A three-year term.

A candidate for one of the above seats must be a qualified voter of Anchorage and of the State of Alaska and shall be a resident of the Bear Valley Limited Road Service Area for three (3) months immediately preceding this election.
