AN ORDINANCE OF THE MUNICIPALITY OF ANCHORAGE AMENDING
28.40.010 AND AMC 28.50.050 REGARDING MUNICIPAL ELECTIONS

THE ANCHORAGE MUNICIPAL ASSEMBLY ORDAINS:

Section 1: That AMC 28.40.010 (B) of the Anchorage
Municipal Code is amended to read as follows:

28.40.010 Ballots--Form.

- A No change.
- B. The clerk shall [DETERMINE THE NUMBER OF BALLOTS TO BE
USED] insure that ballots are prepared for at least 80%
of the registered voters within each precinct to
present all candidates and propositions to the voters. **
The ballots shall be consecutively numbered.
- C. No change.
- D. No change.
- E. No change.
- F. No change.


Section 2: That AMC 28.50.050 is amended to read
follows:

28.50.050 Prohibition of political persuasion near polls.

During the hours the polls are open, no person who is in the
polling place or within 200 feet of any entrance to the polling
place may attempt to persuade a person to vote for or against a
candidate, proposition or question. Nor may any person conduct
other political activities that may pertain to any future
election or potential ballot proposition. For the purposes of
this section, the entrance to a polling place that is in a school
is the entrance to the school building. The election board shall
post warning notices in the form and manner prescribed by the
clerk. (AO 85-75).

Section 3: That this ordinance is effective upon passage
and approval.

Subject: AMENDMENT TO AMC 28.40.010 and 28.50.050 REGARDING MUNICIPAL ELECTIONS

This ordinance would amend the election code to allow for the following:

- 28.40.010 (B) would require a minimum number of at least 80% of ballots to be prepared based on the number of registered voters within each precinct.
- 28.50.050 would add additional prohibitions against political activities including the gathering of signatures for initiative or referendum petitions for any election in the State within 200 feet of the entrance to a polling place on election day.
