5. MAYOR'S REPORT:

Mayor Mystrom distributed and summarized a letter he sent to the State Legislature. He said the State's proposed purchase of the Bank of America Building in Anchorage was expected to save \$1 million in State operating costs. Unfortunately, half of this savings would be because as owner of the building, the State would be exempt from paying property taxes to the Municipality. This "savings" to the State would be transferred as increased taxes to the citizens of Anchorage. He also argued in the letter that continual reductions in State revenue sharing and municipal assistance and unfunded mandates place an increasingly unfair tax burden on Anchorage residents. In response to Mr. Bell, Mayor Mystrom said the State House was considering legislation to remove the State exemption from property taxes on the Bank of America Building. Lastly, the Mayor said a final decision and report to the Assembly on the retirement incentive program was expected tomorrow.

In response to Ms. Clementson, Mr. Raiskums said his office staff performed an audit of the Anchorage Parking Authority (APA) a few months ago, at the request of the APA.

Ms. Abney said she used the word "forensic" in the resolution to ensure a very in-depth audit was performed. She suggested the scope of the audit be clarified during Audit Committee review.

He said for the last year and a half, the store has been a source of problems with inebriates trespassing, littering and urinating in the area. He requested the license be restricted to prohibit sales of certain types of alcohol at the store, in order to discourage inebriates from frequenting the area.

SHERRY ANN SHANNON, manager of Mom & Pops, spoke representing the owner, Sung Ho Su. She explained the owners intended to transfer ownership of the license. She said the management has made changes to clean up the area of the store, to increase safety. Also, all incidents have been reported to the Police Department. She said the owners did not realize those reports would be viewed in a negative light. Shelves have been changed in the store to discourage shoplifting. The new owners have many years of experience in other states with operating grocery and liquor stores, without any problems or alcohol law violations.

In response to Mr. Murdy, the potential owners addressed the Assembly. AN UNIDENTIFIED MAN said he was familiar with the alcohol laws in Alaska.

In response to Mr. Meyer, the man said he agreed to the conditions proposed for operation of the license. Mr. Meyer encouraged him to become involved with the Spenard Community Council.

In response to Mr. Wohlforth, Ms. Shannon said alcohol is not sold to customers who appear intoxicated.

In response to Mr. Murdy, Mr. Hahn Bahng introduced himself to the Assembly. He said he was the new owner of the store, and gave a short history of his life in the United States and experience in the grocery business.

Mrs. Bahng also introduced herself to the Assembly. She said they would try their best to run a clean, responsible operation.

Chairman Begich asked if anyone else wished to speak. There was no one and he closed the public hearing.
