Hecker for his 20 years of service with the Anchorage Police Department, Assemblymembers Abney, Bell, Carlson, Clementson, Kendall, Meyer, Murdy, Taylor, Von Gemmingen, Wohlforth, and Wuerch. (addendum)

Mr. Murdy moved, seconded by Mr. Meyer, and it passed without objection, to approve AR 99-79 and AR 99-80.

Mr. Wuerch read the resolutions while Mr. Murdy and Mr. Carlson presented them.

Officers Nix and Hecker thanked the Assembly for the recognition.

4. Resolution No. AR 99-81, a resolution of the Anchorage Municipal Assembly recognizing and honoring Fire Captain Tim L. Ms. Clementson opposed the resolution. She felt the underlying ordinance which specified commission composition needed review. As the commission exists now, it appears all members of the commission may benefit from its decisions.

Mr. Wohlforth recalled the commission grew out of the CDBG program as a method to give a voice to people who were affected by the program. He felt that was a good idea and fundamental to designing workable projects. The resolution simply asks the administration to ensure the HAND commission composition meets the existing law.

Mr. Wuerch noted the Assembly confirmed the appointments. If members have problems with those appointments, then that confirmation should be revisited.

Mr. Wohlforth noted his request to postpone action on the appointments for further review was defeated. It is rational to ask the administration to look at the issue especially in light of the Ombudsman's report.

Executive Manager Elaine Christian stated the administration felt the appointments complied with the code. It is a 15 member commission whose members must cover six interest categories. More nominees will be coming forward.

Freedom Days Fireworks Festival representatives, to discuss the 4th of July celebration.

MIKE ROBINS, President of Freedom Days Festival, Inc., organizers of the Independence Day celebration in Anchorage for 22 years, proposed the Municipality enter into a partnership with the organizers to ensure a quality celebration which is free to citizens of Anchorage. The organizers will provide the necessary expertise while the Municipality provides seed money. He requested \$25,000 for 1999, \$20,000 for 2000 and \$10,000 for 2001 celebrations. To date, the celebration has been manned by volunteers and financed through private fund raising efforts. Organizers hope to keep citizens in Anchorage spending money locally rather than traveling to neighboring communities for Independence Day celebrations.

Ms. Clementson noted this would be the only 4th of July during the June, 1999, through June, 2000, Millennium Celebration. Perhaps that budget could be a funding source.

Mr. ROBINS added the Municipality did assist the organizers by supplying police coverage and a couple parks employees without charge.

Robert Yahara, regarding the sign ordinance.

MR. YAHARA complained about the lack of progress on the sign ordinance. He urged the Assembly to resurrect AO 98-64(S). Churches need larger signs so people can see and hear the message of God's love.

Director of Community Planning and Development Caren Mathis anticipated the sign ordinance revision would be presented to the Assembly in September.

MR. YAHARA asked that church signs be treated separately from the overall ordinance revision.

11. CONTINUED PUBLIC HEARINGS:

A. Ordinance No. AO 99-32, an ordinance amending Anchorage Municipal Code Chapter 25.25, School Site Selection and Acquisition, by amending Sections 25.25.040 (Conditions of Assembly Site Approval), 25.25.050 (School Site Selection Procedures in General) and 25.25.080 (General School Site Selection Criteria); enacting a new Section 25.25.085 to establish standards, procedures and requirements for Assembly site approval of expansions, reductions or other changes in size and use of approved school sites; and amending other sections to provide for and implement such changes, Assemblymember Clementson. (CONTINUED FROM 2-23-99)

Ms. Clementson announced her intent to table the ordinance and bring it back later.

Chair Von Gemmingen opened the public hearing and asked if anyone wished to speak. There was no one, and she closed the public hearing.

Ms. Clementson moved, to table AO 99-32. seconded by Mr. Murdy,

AYES: Bell, Carlson, Wuerch, Taylor, Wohlforth, Von Gemmingen, Clementson, Meyer, Abney, Kendall, Murdy.

NAYS: None.

At this point, the Assembly agreed to return to AR 99-81 for presentation to Captain Cornelius.

Resolution No. AR 99-81, a resolution of the Anchorage Municipal Assembly **recognizing and honoring Fire Captain Tim L. Cornelius for his 25 years of service** with the Anchorage Fire Department,
Assemblymembers Abney, Bell, Carlson, Clementson, Kendall, Meyer, Murdy, Taylor, Von Gemmingen,
Wohlforth, and Wuerch. (addendum)

Mr. Murdy moved, seconded by Mr. Wuerch, and it passed without objection, to approve AR 99-81.

Mr. Wuerch read the resolution while Ms. Abney presented it. Captain Cornelius thanked the Assembly for the recognition.

- B. Ordinance No. AO 98-192(S), an ordinance amending AMC 9.42.020 by adding a new Subsection pertaining to the designation of areas, trails and other specifically designated rights of way for the lawful use and operation of snowmachines, Assemblymember Carlson.
 - 1. Assembly Memorandum No. AM 81-99. (CONTINUED FROM 2-9-99)

Mr. Carlson announced his intent to continue the public hearing until June 15, 1999 to allow snow machiners who were at the Arctic Man contest to testify.

Chair Von Gemmingen opened the public hearing and asked if anyone wished to speak. She stated people testifying tonight would not be allowed to testify when the matter returned.

PATRICIA McCLURE, representing Rogers Park Community Council, read a council resolution opposing the designation of trails in the Anchorage bowl for snow machine use.

MICHELE CZAJOWSKI, opposed the ordinance and postponing the decision until June. People have waited long enough and would like to know tonight how the Assembly stands on the issue.

BUD RICE, Vice President of the North American Skijor and Skipolk Association, opposed snow machine access to the trails the Association maintains in the Far North Bicentennial Park and Connors Bog because of liability issues. The Association also opposes snow machine use of other multi-use trails in Anchorage because of the risk to walkers, joggers, and skiers. Allowing the access could add to air and noise pollution.

Vice Chairman Clementson assumed the Chair.

TRICIA HERMINGHAUS, Alaska Quiet Rights Coalition member, complained that current snow machine regulations are not obeyed. She felt allowing more use of the machines in the bowl would only increase the noise people now endure. Snow machine use on trails next to residential areas is not compatible.

TIM SAMUELSON, Basher Community Council President, opposed the ordinance. Although he supported development of a statewide snow machine trail system, he believed snow machine use of trails in the bowl conflicted with residents' values of safety and peace. In other states where riding snow machines is a popular tourism activity, larger cities do not allow them to be ridden inside the city limits. The trails always start in outlying, smaller towns. Other states have difficulty enforcing laws governing snow machine use.

KAREN DEATHERAGE a resident of downtown opposed a snow machine trail head downtown. The World Health Organization has declared noise a significant health threat which can lead to physical and mental damage.

DAVE McCARGO, stated the quality of life had declined over the past twenty years. It has become very difficult to find quiet and solitude. He rarely visits Chugach State Park because of the snow machine uses allowed there. If this ordinance passes, people searching for quiet within the city will have no place to go. He pointed out that most of Alaska is open to snow machine users.

POLLY CARR, opposed the ordinance. The added noise, pollution and liability expanding the use of snow machines will bring is not desirable. She also opposed postponement to June 15.

MARK BARFELD, favored the ordinance. His concept was that trails would be built for the exclusive use of snow machines. The Municipality participates extensively in the creation and maintenance of trails for skiers and walkers. Snow machiners should not be excluded.

MAX LOWE, Alaska Snow Mobile Alliance President, asked the Assembly to delay the hearing because most proponents of the ordinance are participating in the Arctic Man event. He favored the ordinance as a way to improve economic development by increasing winter tourism. The ordinance includes safeguards for users of existing trails because each designation must stand on its own merit and be approved separately.

MARILYN HOUSER, opposed the ordinance. The noise level of the city has increased significantly during the past 20 years. Snow machines should not be added to the mix. The roar of snow machines would ruin the relative quiet of local parks. The ordinance opens trails to snow machines before establishing where they will be allowed, setting rules or funding enforcement.

ANN GABLER originally from Wisconsin the snow machine capital of the world, noted large towns there did not allow snow machine use. It is confined to smaller resorts and villages. All machines must be registered and the riders are regulated. The rules are enforced by sheriffs and wardens. In spite of the regulation, education and enforcement efforts it is a high risk activity not compatible with an urban setting.

DWIGHT NEILL, Eagle River Valley Community Council member, was amazed by the reports of pollution generated by snow machines. The proposed ordinance was never intended to put snow machines on ski trails near neighborhoods. He pointed out the areawide trails plan identifies snow machine trails. The original purpose of this ordinance was to make something legal that has been illegal so the trails could be used.

JOAN DANIELS recounted the building of a family cabin in Girdwood. They were very careful during the construction process to avoid disturbing the ground cover. When winter came they were surprised by the snow machine activity nearby and the amount of noise they made. It was like being assaulted by chain saws on wheels. They have sold the property and moved to a quieter area that prohibits snow machines.

CARA SCHNIEDER was concerned about the negative effect snow machine use would have winter air quality. She opposed the ordinance.

SHERRY McPHERSON suggested regulations and trails be identified before the use of snow machines was allowed within Municipal boundaries.

JOHN STEINER, Eagle River Valley Community Council acting chair, advised the council opposed the ordinance. The ordinance contains no provisions for public processes on trail designation, maintenance or enforcement. He also opposed continuing the public hearing until June 15.

CHRIS KROCHIN stated it was generally accepted that snow machines were more polluting than cars and should not be allowed within the city limits.

TAMIA ISHAM, questioned the accuracy of forecasts on the amount of tourist dollars this ordinance change would add to the local economy. She did not feel winter tourists would flock to Anchorage to ride snow machines because of expensive travel and fickle weather. Most snow machine riders are young males who enjoy going fast and taking risks. She did not

want to open her neighborhood to these riders. The promise of big bucks must be weighed against what the community will lose.

BRODIE SHUCK opposed snow machine use within the city. The Municipality must carefully consider how the limited trail space will be used. Money should not be the driving force in the decision.

CLIFF EAMES, Alaska Center for the Environment, opposed the ordinance. While snow machine riding is a popular sport it is not appropriate everywhere. Making reasonable distinctions between incompatible trail uses is not discrimination. Of special concern are the noise and safety conflicts. There is plenty of space to separate incompatible uses. Snow machines may be ridden within Municipal boundaries in Chugach State Park. He mentioned the millions of acres of state and federal land within driving distance which are available for snow machine recreation.

KEVIN MORFORD felt the procedure for designating snow machine trails was inadequate. The ordinance does not contain enough protection for current users of the trails. If the Assembly is serious about pursuing the issue a better ordinance should be generated.

JAN KONIGSBERG said he had lived in the city of lights and noise for nine years. He was surprised the snow machiners asked the Assembly to postpone this hearing so they could recreate instead. It is symptomatic of the group's general attitude that their needs come first. He reported rampant illegal snow machine use in the Sand Lake area and lack of enforcement of existing laws.

JENNIFER DENNIS urged the Assembly not to postpone action on the ordinance. She opposed the ordinance based on safety concerns, invasion of privacy, noise, air pollution and lack of enforcement. The biggest problem is the lack of enforcement. Snow machiners have demonstrated they will not stay on designated trails. If the ordinance is passed, illegal uses will increase.

DICK SNYDER was glad when snow machines were prohibited from the Chester Creek green belt because of the danger they posed to his children. The ordinance has no provisions for regulation or enforcement.

JED WHITTAKER stated safety and education are the fundamental services of government and outrank recreation in funding priority. He felt the money this effort would cost could be better spent on snow removal and sidewalk maintenance so people can walk safely.

ART ISHAM opposed the ordinance and continuation of the hearing. His concerns centered on the inability of law enforcement to police the users and giving land use decision authority to the Parks and Recreation Advisory Commission.

GRETCHEN NELSON described an encounter her husband had with a speeding APD snow machine on a local trail. That was enough to convince her snow machines should not be allowed on trails in the city.

Ms. Von Gemmingen returned to the Chair.

DEBRA COLEMAN, physician, opposed the ordinance because she valued safety. She was concerned combining trail uses with snow machines as proposed by the ordinance would lead to injury and deaths of people and animals.

LINDA BURDLES opposed the ordinance. Snow machiners negatively impact others while skiers, skijorers and dog mushers do not. The ordinance only represents one type of trail user. The desires and values of people who make Anchorage home should be given more weight than efforts to increase tourism dollars. Making Alaska like other states is not a goal of most Alaskans.

MIKE BURDLES opposed the ordinance because it did not include regulations for snow machine drivers. There is no funding or personnel to police snow machine operation. Passage of the ordinance will not protect the health or safety of the residents.

TOM CHOATE noted there are already places in the Municipality to ride snow machines which do not need additional infrastructure or development funds. He opposed expanding the use to other areas because of the safety hazard speeding machines pose.

MICHAEL DENNIS, emergency medical technician, noted rescue units do not have snow machines to retrieve injured snow machiners. He opposed the ordinance.

DALE BERRY opposed the ordinance because of the safety hazards and annoyance snow machine use of local trails will bring to residents. Alcohol, excessive speed and inexperience are principle contributors to fatal accidents involving snow machines. The small percentage of riders who exercise poor judgment create an unacceptable safety risk to neighborhood residents. He supported development of statewide snow machine trails outside the Municipality. He also opposed leaving trail approval authority with a group other than the Assembly.

Chair Von Gemmingen asked if anyone else wished to speak. There was no one.

Mr. Carlson moved, to continue the public hearing on AO 98-192(S) seconded by Mr. Murdy, until June 15, 1999.

Ms. Clementson noted the ordinance had been scheduled for hearing for some time and should be acted on by the current body.

Mr. Kendall reported on the testimony received at a recent town meeting in Chugiak. The main concerns people had were route location, enforcement, state liability laws, and ensuring the Assembly made the final decision on the routes. It was not

a resounding rejection of the idea. He pointed out the Assembly had approved a trails plan that included snow machine routes.

Mr. Wohlforth opposed hearing continuation because it pushed the decision beyond the election and into summer when meetings are sparsely attended. Additionally, new members will not have heard tonight's testimony. He did not believe tourists would come to Alaska to ride snow machines along the Glenn Highway.

Mr. Meyer also opposed continuation of the hearing. However, he felt it was possible to have a route for snow machines somewhere in Anchorage.

Mr. Carlson and Mr. Murdy urged hearing continuation to give the proponents of the ordinance an opportunity to testify.

Mr. Bell felt a compromise was possible but it would take time to identify corridors which did not conflict with other uses. However, he felt ordinance supporters should be heard.

Mr. Bell moved. a substitute a motion to continue seconded by Mr. Murdy, the public hearing to April 27, 1999.

Question was called on whether to substitute Mr. Bell's motion for Mr. Carlson's motion and it passed:
