## 1. CALL TO ORDER:

Assembly Chair Fay Von Gemmingen convened the meeting 5:00 p.m. in the Assembly Chambers, 3600 Denali, Anchorage, Alaska.

## 4. MINUTES OF PREVIOUS MEETING:

Ms. Clementson moved, seconded by Mr. Sullivan,

## 5. MAYOR'S REPORT:

Mayor Wuerch noted on Thursday of this week, the 75 millionth passenger is expected to travel on the People Mover bus system. He congratulated People Mover drivers and employees.

Municipal Manager Harry Kieling reported on an incident which occurred earlier today, at Service High School. He explained yesterday, there was a rumor of threatened violence at the school. Because of that threat, Anchorage Police reacted today according to their policy. He said the Administration would follow up with prosecution, if that is deemed appropriate. Mr. Kieling was pleased that students who heard of the threat acted correctly by reporting the threat to teachers. He encouraged everyone to remind children to immediately report any threats of violence.

A. Resolution No. AR 2001-54, a resolution of the Assembly adopting the recommendations contained in the **Ship Creek Multi-Modal Transportation Plan** with changes recommended by the AMATS Technical Advisory Commission, Planning Department.

Chair Von Gemmingen opened the public hearing and asked if anyone wished to speak.

PAUL LAVERTY urged the Assembly to approve the recommendations of the Planning and Zoning Commission and AMATS Technical Advisory Commission. He requested amendments, to address traffic concerns in the Ship Creek area. Traffic is often slowed because Laidlaw buses stop at all railroad crossings, per State law. There are many Laidlaw buses in the area, as the company's storage lot is located in the Ship Creek area. Also, Mr. Laverty pointed out the Alaska Railroad is working on various capital projects, which may affect location of proposed roadways. Lastly, Mr. Laverty asked an item on page 5 of the executive summary discussing a transit facility in the Ship Creek area be included with the recommendations in the Plan.

STUART HALL, president of the Government Hill Community Council, said the Council supported the proposed Plan. He noted there were some concerns about a new double roadway to replace the A and C Street off ramps, but felt those could be addressed at another stage of the Plan. Mr. Hall also submitted a proposed amendment regarding the Ingra/Gambell couplet extension to Whitney Road.

PAUL NANGLE, owner of a business on Christianson Drive, felt truck traffic on this Drive should cease. He asked the Plan include a provision to meet this goal. Mr. Nangle also disputed the idea of extending the Tony Knowles Coastal Trail to the Ship Creek area.

Chair Von Gemmingen asked if anyone else wished to speak. There was no one, and she closed the public hearing.

Mr. Tesche moved, seconded by Ms. Abney,

to approve AR 2001-54.

Mr. Tesche moved, seconded by Ms. Taylor,

to amend AR 2001-54 in the attached memorandum, AM 119-2001, on page 1, lines 35 and 36 to delete the language in the first "bullet" statement, and on lines 37 and 38 to read: "Ingra/Gambell couplet is extended to Whitney Road, with an off-ramp to Ship Creek Avenue, to provide a new alternative truck route out of the Ship Creek basin which bypasses downtown. The Ship Creek Avenue off-ramp will provide a new more direct access to the Alaska Railroad redevelopment area on the south side of Ship Creek."

Mr. Tesche added his intent was to maintain the proposed construction phasing. He agreed with the Mayor that an at-grade access route for Ship Creek Avenue was acceptable.

Question was called on Mr. Tesche's motion to amend and it passed:

If this comes to pass, an intermodal transit facility will need to be developed within Ship Creek to serve commuter passengers. A covered pedestrian overpass will also need to be needed to connect the transit facility to 3<sup>rd</sup> Avenue."

In response to Mr. Sullivan, Jon Spring of the Planning Department felt the proposed amendment would meet the intent of the Ship Creek Multi-modal Plan. However, it was unusual in this type of sub-plan to direct the Traffic Engineer to prohibit truck traffic on any particular road.

Mr. Sullivan agreed to change the word "prohibit" to read "strongly discourage."

In response to Mr. Tesche, Mr. Spring felt truck traffic generally follows the most direct route. Reducing truck traffic on Christianson Drive, would likely increase use on the closest alternative: 3<sup>rd</sup> Avenue to L Street. Mr. Spring felt it was unlikely trucks would travel through the Fairview area if their destination was the west side of town.

Question was called on Mr. Sullivan's motion to amend and it failed:

Mr. Tesche indicated the hearings would give Assembly members some insight into how certain mayoral appointees intended to carry out their assigned duties.

Mayor Wuerch questioned the need for the ordinance since the Assembly already has the absolute authority to confirm appointees. Various executives have been interviewed during Assembly work sessions.

There was discussion of alternatives that would allow the Assembly an opportunity to meet and question key mayoral appointees in an informal setting.

Mr. Tesche moved, seconded by Ms. Clementson,

to amend AO 2001-69 on line 32 by inserting the word "informal" between the words "conduct" and "confirmation."

Mr. Traini and Mr. Kendall felt the ordinance was unnecessary.

In response to Mayor Wuerch, Mr. Tesche pointed out the ordinance limited the hearings to five particular appointees.

Municipal Attorney Bill Greene reminded the members the code contained a specific definition of "informal meeting" and the amendment may conflict with state statues on open meetings.

Ms. Clementson withdrew her second and the amendment died for lack of a second.

Question was called on the motion to adopt AO 2001-69 and it failed:
