PEGGY ROBINSON, President of the School Board, thanked the Assembly for time spent during the work session. She urged the Assembly to approve the bonds as presented by the School Board and strongly cautioned against adding a third bond or adding on to one of the existing bonds for the Chugiak High School.

CAROL COMEAU, Anchorage School District Superintendent, thanked the Assembly for time spent during the work session. She urged the Assembly to approve the bonds as presented by the School Board. She spoke to the defeat of the bond package last year, the investigation into the reasons why it was defeated and the recommendations that resulted. In response to Mr. Kendall, Ms. Comeau restated that the draft plan is to have the Eagle River high school open by 2006 and that it would be put on the ballot next year. The East Anchorage Middle School still requires a site purchase, Municipality collaboration and it is uncertain whether it can be done by next year or the year after. In response to Mr. Tesche, Ms. Comeau stated that discussions have involved building an 800-student capacity but designed to eventually accommodate 1600 students and that the model design is anticipated to be similar to the Dimond High School. Ms. Comeau stated that approval by the Assembly and the electorate of approximately \$49,500,000 in bonds this spring would not allow the new high school to open any sooner than 2006 due to the process of design, project bid and construction taking until approximately the fall of 2006. Even if the money were there, the process could not be sped up.

JIM YEARGAN, President of the Eagle River Chamber of Commerce, encouraged the Assembly to consider putting the Chugiak High School on the ballot. In response to Mr. Sullivan's question, Mr. Yeargan stated he was a teacher in the school district in the past and testified to the growth of people and housing in Eagle River.

CYNTHIA EBELACKER, parent and pediatric health care provider in Eagle River, testified to having seen firsthand the problems associated with severe overcrowding at Chugiak. He requested support for Ms. Fairclough in her stand-alone bond for the high school construction.

SAM FRIEDMAN, urged a "yes" vote on the school bonds. He stated renovations and improved conditions would benefit the entire Anchorage community.

JIMMIE DANIELS, Principal of Ptarmigan Elementary School, stated Eagle River does not need a new high school this year. He provided comparison capacity statistics on schools between Anchorage and Eagle River/Chugiak. Stated adding the Eagle River high school bond to the others would doom it to failure. Mr. Daniels asked that the school district's opportunity to provide equity to the majority of the students not be taken away to cater to a few. In response to a question from Ms. Fairclough, Mr. Daniels replied that the school board had not been approached regarding busing the kids from Clark to the Gruening Middle School.

PATTI PAIZ, President of the PTA at Ptarmigan Elementary School, stated Ptarmigan Elementary needs the addition proposed by the school district. Overcrowding has broken up a school population and the neighborhood. Voting for other stand-alone bonds or additions to the Administration's recommendation would be casting a vote against their children.

CRYSTAL KENNEDY, representing Eagle River Valley Community Council, recommended a proposition be placed with the school bonds that will provide funding for a second Eagle River High School. Building the school will be good for the students, teachers, community, area property owners and businesses. She requested the second Eagle River high school be placed on the ballot this year.

WENDY MIKOWSKI, representing Eklutna Native Corporation, spoke to several Eklutna developments in the Eagle River/Chugiak/Peter's Creek area. She was saddened to hear the issue pitted one community against another, that all fall within the Municipality of Anchorage and should all vote for school bonds regardless.

GREG KENNEDY, has lived in Eagle River for the past eight years and has children who have graduated, are currently enrolled in Chugiak or soon will be. He requested that the Assembly give voters the opportunity to debate and decide on the issue of a second high school in Eagle River on the ballot in April. The numbers provided during the last debate on the proposed Eagle River high school were wrong. In response to Ms. Fairclough, Mr. Kennedy commented on examples in the packet he provided to Assembly members.

ANN MURPHY, speaking as a parent and an educator, stated that the community professes to hold to high academic standards and social expectations for our children, and yet they are placed in a crowded environment that doesn't allow for opportunities to build relationships, rapport with adults and peers and to build character. He urged consideration that even those kids who are coping may not be getting the best. Ms. Fairclough asked if there was any additional information Ms. Murphy would like to provide. In response, Ms. Murphy said yes. In response to Mr. Sullivan's question, about using the large capacity that exists at the middle schools to alleviate the overcrowding at Chugiak, he stated that it may be a stopgap measure, but there is a danger it will turn into the solution instead of a stopgap and it doesn't provide the quality education and resources that are available at a high school.

DAVID LUNDBERG, spoke as a parent of children at Homestead Eagle River School. He expressed concern about his children receiving a quality education in high school if the current conditions continue to exist at Chugiak High. He stated a need for a second high school.

SARAH WRIGHT, spoke on the perspective of why the new high school is needed and how the delays that have occurred to this point have affected the issue. Lowering the total number of students by moving the 9th graders does not address other issues such as parking and relocatables and will result in overcrowding the middle schools.

JOE PACE, spoke to the overcrowding issue at Chugiak. Considering the growth projected for Anchorage and available land available in Eagle River, it doesn't appear the issue will resolve itself. With additional financial burdens being placed on the public over the next few years, the concern is that if we wait it will be even more difficult to pass this bond next year. He urged the bond package be placed as a stand-alone bond on the ballot. In response to Mr. Sullivan, Mr. Pace restated his position that increasing financial burdens over the next couple of years in the State, as a whole, will diminish the chances of future passage of the bond. Mr. Pace also stated that other projects to be considered for next year would harm the chances of the Eagle River High School.

KATHLEEN STEVENSON, stated the bond failure last year was the result of the Assembly voting against the School Board's recommendations not to lump the two school bonds together. The Assembly must take the heat for the failure. She urged that the community work together to educate the voters of the needs and get the bonds passed. She stated confusion about testifiers concerns about waiting a year to put the Eagle River school on the bond package for this year and

taking the chance of hurting all the schools again, versus waiting until next year, putting it on this year will not move up the date the school would be completed.

K. SCOTT DAUGHARTY, spoke to the school alternatives available within a five-mile radius to those living in Roger's Park in Anchorage versus those living in Eagle River who must travel 24 miles to experience the same alternatives.

ANN MORGESTER, spoke as a teacher at Wendler Middle School. She addressed the school building issues and needs that were hoped for in the last bond package. In response to Mr. Kendall, the Wendler Middle School is included in this year's bond package. In response to Mr. Tesche's comment, Ms. Morgester stated belief that there is support in the Governor's package of school construction bonds proposed statewide if it will get the money needed to bring the building up to code and do the best for the students.

LAEL MARLOW, spoke as a parent from Wendler Middle School, a representative to the Capital Resources Advisory Committee and as a PTA president. The PTA has unanimously endorsed the renovation and needed changes for the school. Urged that the bond package be left as is.

MICHAEL GRAHAM, spoke as the principal from East High School. Anchorage high school principals strongly supported the bond packages as proposed by the superintendent and Anchorage School Board.

JANET MCVEY, spoke as a parent of two children. She had heard the Eagle River High School is going to be needed, is going to be built and won't be affected whether it is on this ballot or not. She urged the Assembly to listen to the wisdom of the school district.

KITTE MILLER, spoke as a parent and as an area wide representative to the Capital Request Advisory Committee putting forth the bond package. She stated that the rationale behind putting these projects on these bonds this year is that it is money that can be used in the next twelve months. The primary concern is that the community supports education but getting the school bonds to pass is a problem. There is a need for continued education.

SHEILA HOWELL, spoke as a member of the Northeast Community Council, and as past president of the PTA at Ptarmigan Elementary. She stated the same questions are being asked now that were being asked then. The bond package is needed and this may be the last chance to keep our kids at home. Eagle River needs the right to vote on their bond alone if that's what they want.

DIANE ETTER, spoke as an East High School parent and a past member of the Anchorage School District Capital Improvement Committee. She urged the Assembly to pass the bond exactly as it is proposed by the Anchorage School District. She put forth a concern that the failure of the bond last year may be repeated this year. She expressed hope that the Assembly will pass the bond exactly as it is written. In response to a question, Ms. Etter stated that the CIP discussed what the bonds would include in future years and that they would continue with the high school renovations. She could not recall when the committee thought the high school should be placed on the bond proposal for Eagle River. In response to Mr. Van Etten, Ms. Etter indicated her participation on the CIP committee has been in Anchorage, not statewide.

BILL STARR, stated the need for an additional Eagle River/Chugiak high school is strongly supported. He spoke to the fact that growth, demographics, quality of education, timeliness of the solution, left-behind students, upcoming students, community development and overall need had been clearly demonstrated by testimony this evening.

NANCY DAVIS, addressed Eagle River development growth estimates and planned residential land development projects. In response to Ms. Shamberg's question as to what is the economic force that will drive that many people into Eagle River and build new homes, Ms. Davis responded it is slow, gradual growth and that Eagle River is where the available land is.

TOM LOONEY, has two daughters at Homestead Elementary School. One option proposed is to bus Chugiak students to other high schools but this significantly limits student's abilities to participate in activities and socialize with other students. He believed the Assembly should enthusiastically support all the bond issues and the Eagle River High School. He stated the 2020 Plan calls for growth in Eagle River, that there is an overcrowding issue today and that it will only get worse.

SAM DANIEL, President of the Girdwood Elementary/Junior High PTA, spoke of concern for Girdwood parents and residents regarding the local landfill. The Girdwood School and playgrounds are built on top of the landfill. The School District has been stellar in trying to come up with a plan. He requested the Assembly support the Municipality's consideration of source removal that involves digging up the landfill and relocating it. He urged the Assembly to support finding and allocating the funds for source removal as a permanent solution to the problem.

RYAN STARR, a student at Chugiak High School, provided statistics and first-hand information on portables, numbers of children, overcrowding and port-a-potties. In response to Mr. Tesche's request, Mr. Starr verified the portables and port-a-potty's spoken of in pictures provided by Ms. Fairclough. Mr. Starr indicated that the port-a-potty was provided for approximately 450-1000 children in the upper area of the high school.

CHRIS WALLER, spoke of his support for the Eagle River residents who support of the passing of the bond for an additional Eagle River school. He discussed the amount of new homes and development in Eagle River. He urged that educational support be put in place to support the expansion.

MARY BOYDEN, voiced frustrations at the possibility that her children may not see a new Eagle River high school and she is having to look at alternative programs in Anchorage that limits job possibilities or placing the children in private school. She urged the Assembly to demonstrate to Eagle River/Chugiak that they are part of the community by voting on that school bond.

LINDA KELLY, represents the Chugiak Youth Sports Association. She provided statistics on numbers using the programs and money paid to the Anchorage School District for usage of facilities. She spoke of the overcrowding impacts that extend beyond the students. She is discouraged by the extremely hard logistics in implementing any alternatives and interim solutions to building a new school.

DAN PHELPS, an Eagle River resident, indicated disappointment with the conditions at Bartlett High School. The conditions, lack of class choices, lack of participation opportunities, split lunch times and lack of socialization time, all affected his daughter and subsequently her sister. He urged Anchorage to support Eagle River.

KENA BRISHNA, complimented the quality of education her children receive in Alaska but indicated she was very upset at the overcrowding at Chugiak. She spoke to the growth and salability of homes in the area and the number of military families. She spoke to the advanced opportunities available in a high school (9th and higher) rather than a middle school with 7th, 8th and 9th grade.

LYNN AMAL, Eagle River resident since 1974 and a Chugiak High School graduate of 1983, addressed the ages of families moving in and who's buying homes and having children. She has seen the area grow considerably.

RITA HOLTHOUSE, represents the Anchorage School Board. She spoke to the issue of adding the Eagle River High School to the bonds. She stated three points: 1) Including the high school on this year's bond will not cause it to be built any sooner, 2) adding the bonds in any form to the school district bonds could jeopardize the bonds for the second year in a row, and 3) the delay would allow for a thorough analysis of the demographics regarding the number of high school students expected in that area in future years.

HARRIET DRUMMOND, represents the Anchorage School Board. She provided statistics on family numbers and capacity. She stated belief that it is fiscally irresponsible to add secondary space to Eagle River at this time. She stated that bond propositions only ask the voters for money that can be spent in the next 12 months after the election. She urged the Assembly to take the Anchorage School District's bond package as they are, without changes. Chairman Traini asked if anyone else wished to speak. There was no one, and he closed the public hearing.

Assembly members discussed the motion.

Mr. Kendall moved, Seconded by Mr. Tremaine, to postpone AO 2002-18 until 2-12-02.

Question was called on the motion to postpone AO 2002-18 to 2-12-2002 and it failed:

DAVID MANZER, passed until next week.

VIVIAN MENDENHALL, testified on AO 2002-29. She represented the Anchorage Audubon Society, which supports natural open space for nature oriented recreation and wildlife habitat. She is opposed to the bond proposal as it stands. 1) Indicates other sites are suitable for the Little League sites as recommended in the study. 2) Other sites would be less expensive. 3) The cost of developing the fields at the Far North Bicentennial Park is not mentioned in the ordinance or the proposed ballot language. 4) The ordinance states that if the bond fails, the ball fields will be put in Far North Bicentennial Park and this is unacceptable. Other sites exist.

Ms. Fairclough moved, Seconded by Ms. Von Gemmingen, and it passed with Mr. Kendall objecting, to extend public hearing until 11:15 p.m.

VIVIAN MENDENHALL, responded to Mr. Van Etten's question that she had not seriously considered combining the general park bond with the baseball field bond.

JILL WIDDICOMBE, is against the Mayor's proposed \$4.5 million separate Simonian Little League bond. It lacks sincerity, would cause more antagonism among the citizens of Anchorage, it endangers the larger recreational bond and there are superior alternatives available. She supported the \$8.5 million general parks and recreation bond.

TOBY WIDDICOMBE, urged rejection of the Mayor's proposed \$4.5 million separate Simonian Little League bond. He voiced the same issue as Jill Widdicombe and rejecting the Mayor's proposed bond would send a clear message.

SHEILA HOWELL, representing the Northeast Community Council, voiced concerns about poor language in the bond. She spoke to the importance of maintaining the area as wooded for children and great-grandchildren, and the other available land for ball fields. She opposes adding it on to another parks and recreation bond.

ANDY MELTZER, strongly opposed to the Mayor's proposed bond for the baseball fields for Simonian Little League. He is in favor of a reasonable and financially responsible solution for the Simonian Little League. He provided information and asked questions on financial statistics as relates to the project, discussed other alternatives, and asked the Assembly members to vote with fiscal responsibility on this issue.
