In response to Ms. Von Gemmingen, Mr. Otto stated there were two "Summary of Economic Effect" statements, one for the Utilities and one for General Government. The General Government portion over the life of the contract is \$1.7 million, while the Utility is \$3.8 million.

Mr. Tesche inquired into the rate relief request on the Utility statement, asking if the recent tariff increase requested by the Administration from the RCA not take into consideration the wage increases negotiated? Municipal Light &Power General Manager, Mr. Mike Scott, stated in the original filing with the RCA there was just under \$500,000 for the contract purposes.

That portion is included in the rate that is already under collection. The other half will not be collected until such time as there is a general rate increase, thus it would come either from net income or some other means.

Question was called on the motion to approve AR 2002-272 and it passed.

Mr. Tesche moved, seconded by Ms. Fairclough, and it passed without objection, to postpone indefinitely AO 2002-131.

- 14G. Ordinance No. AO 2002-132, an ordinance of the Anchorage Municipal Assembly Amending Anchorage Municipal Code Section 1.15.180, prohibited acts, by adding a new subsection K, regarding **public access to Municipal records**, Assemblymember Tesche.

Chairman Traini opened the public hearing and asked if anyone wished to speak. There was no one, and he closed the public hearing. Chairman Traini noted the sponsor wished to postpone indefinitely.

Mr. Tesche moved, seconded by Ms. Fairclough, and it passed without objection, to postpone indefinitely AO 2002-132.

- 14H. Ordinance No. AO 2002-120, an ordinance amending Chapter 23.10 of the Anchorage Municipal Code to provide an **exemption from plan review and permit fees** for projects built within a deteriorated area, Assembly Chair Traini, Mayor Wuerch, Assemblymembers Tesche, Whittle, and Sullivan.
 - 1. Assembly Memorandum No. AM 726-2002.

Chairman Traini opened the public hearing and asked if anyone wished to speak.

MARC MARLOW testified in support of the ordinance.

In response to Ms. Von Gemmingen, Mr. Marlow advised routine maintenance and painting had been performed on the MacKay Building and his hope was to eventually rehabilitate the building to full productivity in the future.

Mr. Sullivan advised the Chairman that when he first sponsored this ordinance he did not realize it was referring to a specific piece of property. Because the text of the ordinance speaks directly to the MacKay Building Mr. Sullivan declared a potential Conflict of Interest. Mr. Sullivan advised the estate of his late brother does have an interest in the MacKay building property.

Mr. Tremaine moved, seconded by Ms. Fairclough,

does Mr. Sullivan have a substantial financial interest in the matter before the Assembly?

The Assemblymembers discussed Mr. Sullivan's interest in the MacKay Building. Chairman Traini ruled that Mr. Sullivan has a Conflict of Interest and excused Mr. Sullivan from voting on the issue.

Ms. Taylor requested a work session on the status of Mr. Marlow's projects.

Chairman Traini asked if anyone else wished to speak. There was no one, and he closed the public hearing.

Mr. Tesche moved, seconded by Ms. Fairclough,

to adopt AO 2002-120.

The Assemblymembers then discussed the pending ordinance.

In response to Ms. Fairclough, Office of Planning, Development and Public Works Director Craig Campbell, advised that the two ordinances passed by the Assembly establishing deteriorated property areas include the MacKay Building area, the Annex, and the Ship Creek Building. to amend AO 2002-120 to read: Line 21, delete "deteriorated

seconded by Mr. Tremaine, and it passed without objection, with Mr. Sullivan abstaining property as defined in Anchorage Municipal Code 12.35.005" and insert "existing buildings, as defined in this title, located on deteriorated property as defined in Anchorage Municipal Code 12.35.005."

Ms. Von Gemmingen moved, seconded by Mr. Tremaine, and it passed without objection, with Mr. Sullivan abstaining

to amend AO 2002-120 to read: Line 27, delete "deteriorated property as defined in Anchorage Municipal Code 12.35.005" and insert "existing buildings, as defined in this title, located on deteriorated property as defined in Anchorage Municipal Code 12.35.005."

Mr. Kendall expressed his concern in creating exempting legislation, which could be used by many other groups seeking property tax exemption by using the deteriorated verbiage.

Mr. Tremaine moved, seconded by Mr. Kendall,

to amend AO 2002-120 as follows: Line 27 and 28, Plan review fees (take out "are not required") for the rehabilitation of existing buildings, as defined in this title, located on deteriorated property as defined in Anchorage Municipal Code 12.35.005 and insert ("will be refunded when such property moves into the construction phase.")

Question was called on Mr. Tremaine's motion to amend AO 2002-120 and it failed.

AYES: Fairclough, Van Etten, Kendall, Tremaine.

NAYES: Tesche, Whittle, Taylor, Traini, Von Gemmingen.

ABSTAIN: Mr. Sullivan.

Ms. Fairclough expressed her concerns regarding the Assembly being arbitrary. and was concerned for future development in the City. She said she would vote no.

Mr. Kendall also said he would vote no.

Mr. Tesche, Mr. Whittle, and Mr. Van Etten urged a yes vote.

Question was called on the main motion to adopt AO 2002-120 as amended, and it passed.

AYES: Tesche, Whittle, Taylor, Traini, Von Gemmingen, Van Etten, Tremaine.

NAYES: Fairclough, Kendall. ABSTAIN: Mr. Sullivan.

Mr. Tesche moved, seconded by Ms. Von Gemmingen,

for immediate reconsideration of AO 2002-120 as amended.

Question was called on the motion for immediate reconsideration of AO 2002-120 as amended and it failed.
