#### 4. **NEW PUBLIC HEARING**

Ordinance No. AO 2003-115, and ordinance of the Municipality of Anchorage amending AO 2003-8 4.A. regarding keg or container registration to change the effective date, Assembly Chair Traini.

Assembly Memorandum No. AM 599-2003.

Chair Traini read this ordinance title and opened Public Hearing. There being no one to testify, he closed Public Hearing and explained that the purpose of this ordinance was to change the effective date of AO 2003-08. He explained it would effect the date for requirement to begin registration of kegs or containers holding alcoholic beverages and held for sale or lease, changing from August 1, 2003 to October 1, 2003. This would allow time for the revision of Municipal Code Section 10.50.050, to reflect suggestions made during the July 11, 2003 work session. Chair Traini stated that revising the ordinance prior to the effective date would ensure successful and effective implementation. He stated that this change would make it easier on distributors. He called for a motion to approve this ordinance.

Ms. Fairclough moved, to approve AO 2003-115, to become effective Mr. Tesche seconded, October 1, 2003.
