(9) "drunken person" means a person whose physical or mental conduct is substantially impaired as a result of the introduction of an alcoholic beverage into the person's body and who exhibits those plain and easily observed or discovered outward manifestations of behavior commonly known to be produced by the overconsumption of alcoholic beverages;

"freestanding" has the meaning given in AS 18.35.301(i)(I);

§ 18.35.301. Prohibition of smoking

(1) "freestanding" means a building that is not supported by another structure and does not share ventilation or internal air space with an adjoining structure and smoke from the building cannot travel into the adjoining structure;

"intoxicated" has the meaning given in AS 11.81.900(b)(35)(34);

AS § 11.81.900

§ 11.81.900. Definitions

(b) In this title, unless otherwise specified or unless the context requires otherwise,

...

(35) "intoxicated" means intoxicated from the use of a drug or alcohol;

In turn, "drug" here means

(21) "drug" has the meaning ascribed to it in AS 11.71.900;

(10) "drug"

(A) means

(i) a substance recognized as a drug in the official United States Pharmacopoeia, official Homeopathic Pharmacopoeia of the United States, or official National Formulary, or any supplement to these publications;

(ii) a substance intended for use in the diagnosis, cure, mitigation, treatment, or prevention of disease in humans or animals;

(iii) a substance, other than food, intended to affect the structure or any function of the body of humans or animals; and

(iv) a substance intended for use as a component of any article specified in (i), (ii), or (iii) of this subparagraph;

(B) does not include a device or its components, parts, or accessories;

16.65.005 - Definitions.

In this chapter:

Business means any natural person or legal entity (such as, without limitation, a business-for-profit corporation, nonprofit corporation, partnership, limited liability company or trust) that undertakes to provide goods or services to the public or to persons who are members of a private group that is eligible to obtain the goods or services, regardless of whether the business exists or is conducted for the purpose of making a profit.

Electronic smoking device means an electronic or battery-operated device that will deliver tobacco, nicotine, or marijuana vapors for inhalation.

Employee means any person who is employed by any business for compensation or works for a business as a volunteer without compensation.

Enclosed area means all interior space within a building or other facility between a floor and a ceiling that is enclosed on all sides by walls, windows, or doors extending from the floor to the ceiling.

Marijuana and marijuana products have the meaning given in AS 17.38.900.

Place of employment means an area under the control of an employer, that employees may frequent during the course of employment, including, but not limited to, work areas, employee lounges, restrooms, conference rooms, classrooms, cafeterias, hallways, and vehicles.

Private club means an organization (whether a legal entity or an informal association of persons) that is the owner, lessee, or occupant of a building or portion thereof used exclusively for club purposes at all times, which is operated solely for a recreational, fraternal, social, patriotic, political, benevolent, or athletic purpose, but not for pecuniary gain, and has been granted an exemption from the payment of federal income tax as a club under 26 U.S.C. Section 501.

Public place means any enclosed area to which the public is invited or into which the public is permitted, including but not limited to, educational facilities, entertainment, food and beverage service, offices, retail stores, and transportation facilities and vehicles accessible to the general public.

Smoking means inhaling, exhaling, burning or carrying any lighted tobacco or marijuana product.

Town Square Park means Lots 2, 3, 4, 6B, and 7A, and included right-of-way, Block 51, Anchorage Original Townsite.
