Subject: For Review: Potential Conflict of Interest Question (Green Bank)

Ethics Officer:

I hope you and yours are well in these challenging times. I have an ethics question revolving around 49SAF's need to develop and subsequently evaluate an upcoming investment opportunity and how that intersects with conflict of interest provisions at the Municipality.

Introduction:

49SAF has approximately \$1 million verbally returned to us by our fund managers due to the COVID crisis. We have stated our interest is to deploy this capital more aggressively given Alaska's economic condition. Given the overall funding landscape, the question is how to do this effectively and best.

One project likely to come before 49SAF for funding consideration is a "Green Bank," in line with the Municipality of Anchorage's climate action plan. This public-private partnership would enable property owners to receive loans to pay for energy efficiency upgrades. While the amount sought is not yet defined, we estimate probably around \$1 million in capital would be sought from 49SAF for investment in such an entity.

At issue:

A 49th State Angel Fund advisory committee member (Steven Trimble, cc'd) will likely either advise or help as part of the MOA team to conduct research, engage stakeholders, and create a proposed investment structure for such a "Green Bank" project. That will be subsequently reviewed by 49SAF in one of our regular meetings.

Since Mr. Trimble owns Arctic Solar Ventures, Alaska's largest solar integrator, he acknowledged in our May 20 committee meeting that should such a proposal emerge, he may be conflicted. Such a project, if funded by the 49SAF and also successful, could theoretically drive increased business to Arctic Solar Ventures, as it would enable increased capital to pay for energy efficient upgrades by property owners.

49SAF believes this does not present a conflict of interest per our program's federal

guidance. While that guidance does hinge around "personal financial interests," that term is specifically defined as investment into a company or fund in owned by an Insider (in this case Mr. Trimble). More specifically: Investing in Mr. Trimble's company, Arctic Solar Ventures, would be a clear conflict of interest violation since he is an Advisory Committee member; investing in a Green Bank project which might or might not benefit his company would not. The 49SAF has no concerns about the appearance of conflict of interest in this case.

From here, our process: Mr. Trimble will help advise upon and formulate a Green Bank proposal. Then, should such a "Green Bank" investment proposal be formalized by the team and submitted to the 49SAF for investment evaluation, Mr. Trimble will recuse himself from that discussion and vote.
