A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING AND RE-APPROPRIATING STATE OF ALASKA GRANT IN SENATE BILL 18, WHEN TENDERED, OF THIRTY-SEVEN MILLION DOLLARS (\$37,000,000) TO THE PUBLIC WORKS DEPARTMENT FOR VARIOUS FACILITY IMPROVEMENTS, INCLUDING FUNDS FOR A NEW MULTI-USE FACILITY.

WHEREAS, the State of Alaska has appropriated to the Municipality of Anchorage legislative funding per AS 37.05.315 for general government;

WHEREAS, the Administration and the Assembly have reviewed the grants offered by the State of Alaska;

WHEREAS, since the passage of AR 2013-252, the allocation of funds for projects identified through AR 2013-252 should be changed and the funds re-appropriated to reflect the allocation changes;

WHEREAS, the State of Alaska grant is based, in part, on the addition of a facility for indoor, multiuse courts for tennis and other court-based sports according to the State Total Project Snapshot Report for Project 80's funding:

WHEREAS, it is the Municipality's intent to enter into a contractual arrangement with the Anchorage Tennis Association for construction of the facility, on a reimbursable basis, subject to Assembly approval;

WHEREAS, the specific facility is best described separately from Project 80's for purposes of a separate reimbursable grant arrangement, although included for convenience in the Project 80's capital budget request; and

WHEREAS, a duly advertised public hearing was held in accordance with Section 6.10.085 of the Municipal Code; now, therefore,

THE ANCHORAGE ASSEMBLY RESOLVES:

<u>Section 1.</u> The legislative grant, when tendered, from Senate Bill 18 from the State of Alaska of Thirty-seven million dollars (\$37,000,000) is hereby appropriated, and re-appropriated from AR 2013-252, to the Public Works Department for projects as identified in the attached Project 80's Allocation Table, as follows:

\$33,000,000 Areawide Capital Improvement Fund (401) for projects identified in the Allocation Table submitted herewith.

\$ 4,000,000 Eagle River Parks and Recreation Capital Improvement Fund (462) for various facility improvements.
