1 **A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING A**
2 **FEDERAL TRANSIT ADMINISTRATION (FTA) SECTION 5309 BUS AND BUS-**
3 **RELATED GRANT AND APPROPRIATING TWO MILLION NINE HUNDRED FOUR**
4 **THOUSAND EIGHT HUNDRED FIFTY-NINE DOLLARS (\$2,904,859) AND A**
5 **CONTRIBUTION OF SIXTY-THREE THOUSAND EIGHT HUNDRED EIGHTY-TWO**
6 **DOLLARS (\$63,882) FROM THE 2013 APPROVED OPERATING BUDGET, AREA-**
7 **WIDE GENERAL FUND (101), PUBLIC TRANSPORTATION DEPARTMENT, TO**
8 **THE PUBLIC TRANSPORTATION CAPITAL FUND (485), PUBLIC**
9 **TRANSPORTATION DEPARTMENT, FOR THE CONSTRUCTION OF**
10 **INTERMODAL FACILITIES AND IMPROVEMENTS TO THE DIMOND TRANSIT**
11 **CENTER.**

14 WHEREAS, the Municipality of Anchorage periodically applies for and receives
15 Federal Transit Administration grants for capital, operational and other purposes in
16 connection with providing public transportation and related facilities; now, therefore,

18 **THE ANCHORAGE ASSEMBLY RESOLVES:**
19

20 **Section 1.** That the Administration is authorized to accept a 2013 Federal Transit
21 Administration Section 5309 Bus and Bus-Related grant.
22

23 **Section 2.** That the sum of Two Million Nine Hundred Four Thousand Eight
24 Hundred Fifty-Nine Dollars (\$2,904,859) is hereby accepted and appropriated as a
25 grant from the Federal Transit Administration to the Public Transportation Capital
26 Fund (485) to fund the Phase I construction of the Dimond Intermodal Facility.

28 **Section 3.** That the sum of Sixty-Three Thousand Eight Hundred Eighty-Two
29 Dollars (\$63,882) is hereby appropriated as a contribution from the 2013 Approved
30 Operating Budget, Area-wide General Fund (101), Public Transportation Department,
31 to the Public Transportation Capital Fund (485), Public transportation Department, to
32 fund the support of Municipal Central Service Agencies to this grant.

34 **Section 4.** This resolution shall be effective immediately upon passage and
35 approval by the Assembly.
