The Municipal Clerk's Office notifies the public that the Assembly may utilize sign-up sheets for public testimony at the October 8, 2013 Regular Assembly Meeting. The sign-up sheets will be available at 6:00 p.m. and the purpose is to facilitate public testimony on the following public hearing items:

14.H. Resolution No. AR 2013-250, a resolution of the Municipality of Anchorage appropriating, State of Alaska grant in Senate Bill 18, when tendered, of \$37,000,000 to the Public Works Department for various facility improvements, Office of Management and Budget.

14.I. Resolution No. AR 2013-252, a resolution of the Municipality of Anchorage appropriating, State of Alaska grant in Senate Bill 18, when tendered, of \$26,500,000 to the Public Works Department for various facility improvements, Assemblymembers Starr, Traini and Trombley.

14.K. Ordinance No. AO 2013-108, an ordinance of the Anchorage Municipal Assembly to save the expense of a special election by suspending the ordinance as provided in Charter §3.02 and submitting the referendum on AO 2013-37(S-2) to the voters at the regular municipal election scheduled for April 1, 2014, Assemblymembers Traini, Gray-Jackson and Honeman
