A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THREE THOUSAND FIVE HUNDRED DOLLARS (\$3,500) FROM THE AREA WIDE GENERAL FUND (101) BALANCE TO THE ASSEMBLY TO PAY ATTORNEY FEES IN THE MATTER OF NATIVE VILLAGE OF EKLUTNA VS. MUNICIPALITY OF ANCHORAGE, BOARD OF ADJUSTMENT AND NATIONAL BANK OF ALASKA.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of Three Thousand Dollars (\$3,500) is hereby appropriated from the Areawide General Fund (101) Balance to the Assembly's Legal Services – General Account (Fund 101-Account 1010-3111) to pay attorney fees to the Native Village of Eklutna in the matter of Native Village of Eklutna v. Municipality of Anchorage, Board of Adjustment and National Bank of Alaska.

Section 2. This resolution is effective immediately upon passage and approval.
