A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY APPROPRIATING  
ONE HUNDRED NINETY EIGHT THOUSAND SEVEN HUNDRED AND TEN DOLLARS  
(\$198,710) FROM AREAWIDE GENERAL FUND (101) BALANCE TO THE  
DEPARTMENT OF HEALTH AND HUMAN SERVICES TO PROVIDE FOR AN  
INCREASE IN THE MUNICIPAL OPERATING FUNDS FOR THE HUMAN SERVICES  
MATCHING GRANT PROGRAM

**Section 1:** That the sum of \$198,710 is appropriated from Areawide General Fund  
(101) Balance to the Department of Health and Human Services to provide for an increase  
in the Municipal Operating Funds for the Human Services Matching Grant Program  
(HSMG).

**Section 2:** That the funding is to be used for the purpose of providing funding for  
the FY 2001 HSMG for the following agencies:

Food Bank of Alaska	\$ 29,770
Lutheran Social Services	\$ 32,640
