1 A RESOLUTION AUTHORIZING THE MUNICIPALITY TO GRANT A TWENTY-FOOT (20')
2 WIDE ELECTRIC EASEMENT WITHIN LORETTA FRENCH PARK, LOTS 4, 5, 7, 8, 9, 11, 12,
3 13 AND 14, SECTION 16, T15N, R1W, S.M., TAX #'S 051-194- 03, 04, 05, 06, 08, 09, 10, 11,
4 AND 12, GENERALLY LOCATED ON THE WEST SIDE OF OLD GLENN HIGHWAY AND
5 SOUTH OF NORTH BIRCHWOOD LOOP ROAD

8 WHEREAS, improvements within Loretta French Park, Lots 4, 5, 7, 8, 9, 11,
9 12, 13 and 14, Section 16, T15N, R1W, S.M. require electrical service provided by
10 Matanuska Electric Association, Inc. (MEA) in order to meet the needs of the Department of
11 Cultural and Recreational Services, and;
12

13 WHEREAS, in order to provide the electric service to Loretta French Park,
14 MEA requires a twenty-foot (20') wide electric easement for the purpose of installing an
15 electric service line, and;
16

17 WHEREAS, after installation of the electric service line, MEA and Cultural
18 and Recreational Services are to determine and finalize the easement area(s) required and
19 execute an easement document.
20

21 WHEREAS, the subject easement is found to be of no substantial value to
22 the Municipality.
23

24 NOW THEREFORE, the Anchorage Assembly resolves:
25

26 SECTION 1. That the Administration is authorized to grant the requested
27 electrical easement to MEA in the following location:
28

29 A twenty-foot (20') wide electric easement within Loretta French Park, Lots 4, 5, 7, 8, 9,
30 11, 12, 13 and 14, Section 16, T15N, R1W, S.M. generally located on the West side of
31 the Old Glenn Highway and South of North Birchwood Loop Road.

33 SECTION 2. This resolution shall take effect immediately upon passage and
34 approval.
