Reports

AFD, Fire Chief Hettrick

- Bond for EMS equipment each year does not allow to completely refresh certain items. We have different versions of various items
- We are asking to bum up the tax cap in ems area wide fund so we can lease our equipment, completely refreshing our inventory and the vendor will maintain the equipment. Includes power load gurneys for ambulances.
- This will result in a 3 million savings over 10 years, 2019 prices would be awarded this year from the vendor
- This would also include AED replacement for APD and Bluetooth capability.
- Ballot language will be clear enough for understanding and we will have a media campaign. There will be an introduction to the assembly work session and a vote

- Request for resolution by PSAC and input on wording is welcome.
- Academy-30 received final offers. We are expecting an April/May graduation.
- Working on revised budget to reflect actual costs of the fire department 23-25 retirees expected this year
- Positions will be posted soon for QA/QI and Community Risk positions.
- EMS calls have increased but transports have decreased, potentially due to CORE team. Fire call volume has increased by 7% compared to 2018.

APD, Lieutenant Burington

- New Intel analyst position has been filled and started in December this is a non-sworn position. Making connection between people patterns in criminal activity.
- PSP evaluation complete, report expected in February.
- Citizen's Academy starts tonight.
- CAP 1 has been working to get 8-80 billings for nuisance ordinances sent out. Bills are required to go out the 15th of each month.
- Bond being worked on purchasing of additional cars was taken out of budget. We will be prepping a bond to present to PSAC for support.
- HQ Computer crimes has moved in with the exception of lab. The beginnings of working on the Elmore location remodel has begun.
