### 2. Action Items:

Minnesota Drive Non-Motorized Pavement Project

❖ I saw that the TAC agenda next week includes the "Minnesota Drive Non-Motorized Pavement Project" and I'm hoping to attend the meeting to comment. If I can't make it, I wanted to email/forward the Spenard and Turnagain Community Council's resolutions from 2023 (attached) addressing the "cheese grater" that was installed without any public involvement or notice as part of the DOT&PF's Highway Safety Improvement Program project to improve the lighting along the roadway.

I'm very supportive of expanding the AMATS Minnesota Drive Non-Motorized Pavement Project to include adding the missing 4th crossings at Northern Lights and Benson as well as additional HAWK signals for mid-block crossings along Minnesota Dr. Though it is disappointing that the DOT&PF has not removed the cheese grater through the HSIP process, these solutions will make non-motorized travel safer, more convenient, and are in-line with what the councils' requests.

# **Turnagain Community Council Resolution**

# Regarding Placement of a Wall/Barrier Fence in the Minnesota Drive Median Between Benson Boulevard and West Northern Lights Boulevard

WHEREAS, the Turnagain Community Council (TCC) is an all-volunteer, self-governing neighborhood organization recognized in the Municipality of Anchorage Charter that represents the interests of the residents and property owners of the Turnagain/West area of Anchorage; and

WHEREAS, the purpose of community councils is to provide direct and continuing means of citizen participation in government and local affairs; and

WHEREAS, Minnesota Drive, Benson Boulevard (Benson), and West Northern Lights Boulevard (WNL) border Turnagain Community Council and are on the Municipality of Anchorage's "high injury network," meaning a high number of people have been killed and severely injured in traffic crashes, and the south side of the intersection of WNL with Minnesota Drive — with no designated pedestrian crosswalk — is particularly hazardous; and

WHEREAS, the portion of Minnesota Drive referenced above is part of the Spenard Corridor Plan (2020) and the plan vision includes Spenard being a "model for the region for its contribution to the citywide and regional transportation system and its network of urban active transportation facilities" and a "branded district;" and

WHEREAS, the Spenard Corridor Plan also includes goals to "create great public streets," to "create a safe pedestrian and bike network," to "accommodate safe and balanced roadway access," and to "design for Anchorage;" and

WHEREAS, the Alaska Department of Transportation and Public Facilities (DOT&PF) Highway Safety Improvement Program (HSIP) is intended to identify and fund highway safety projects that maximize lives saved and injuries eliminated per dollar spent; and

WHEREAS, this summer/early fall DOT&PF constructed two projects on Minnesota Drive at Benson and WNL, including the "Minnesota Drive: Tudor to 15<sup>th</sup> Avenue Pavement Preservation," and the "HSIP: Anchorage Pedestrian Lighting, Phase II;" and

WHEREAS, as part of DOT&PF's projects along Minnesota Drive, a tall, opaque, metal grid fence on top of a concrete barrier was installed in the median of the roadway between Benson and south of WNL, with no apparent outreach/discussion with the Spenard and Turnagain Community Councils prior to this barrier fencing installation as to its:

- Visual aesthetics;
- Effectiveness to address dangerous pedestrian mid-block crossings;
- Improvements to provide safe pedestrian intersection crossings; and
- Obstructed driver sightlines;

NOW THEREFORE BE IT RESOLVED, Turnagain Community Council concurs with Spenard Community Council in rejecting objects to the design and construction of the Minnesota Drive Barrier Fence, which does not meet the vision for the neighborhood, does not solve the pedestrian dangers at the Minnesota Drive, Benson Boulevard, and West Northern Lights Boulevard intersections, and, in fact, has the potential to increase the safety hazard by obstructing driver, pedestrian and bicycle rider visibility in this area; and

**NOW THEREFORE BE IT FURTHER RESOLVED**, Turnagain Community Council requests the following remedies for this project:

- Collaborate with community stakeholders (including Spenard and Turnagain Community Councils) and the public to identify effective solutions and pedestrian improvements along Minnesota Drive in this area, which may include:
  - Removal of the recently-installed center barrier fencing along Minnesota Drive between Benson Boulevard and West Northern Lights Boulevard (including the dangerous guy-wire at the north end of the median) and in its place:
    - Installation of a fixture that is transparent, attractive and that adequately addresses pedestrian and driver safety; and
    - Addition of two crosswalks to the "missing" sections (the fourth leg) at Minnesota Drive at both Benson and West Northern Lights Boulevards, which include adding time to the traffic light cycles to allow for safe pedestrian crossing; and
- Implement these safety and visual improvements as soon as possible.

## A Resolution on the Minnesota Drive wall

WHEREAS, the Spenard Community Council ("SCC") is an organization representing the interests of the residents of the Spenard area of Anchorage; and

WHEREAS, the purpose of community councils is to provide a direct and continuing means of participation in local government and local affairs; and

WHEREAS, Minnesota Drive, Benson Boulevard, and Northern Lights Boulevard are within Spenard and are on the municipality's "high injury network," meaning a high number of people have been killed and severely injured in traffic crashes; and

WHEREAS, the Spenard Corridor Plan (2020) vision includes Spenard being a "model for the region for its contribution to the citywide and regional transportation system and its network of urban active transportation facilities" and a "branded district;" and

WHEREAS, the Spenard Corridor Plan also includes goals to "create great public streets," to "create a safe pedestrian and bike network," to "accommodate safe and balanced roadway access," and to "design for Anchorage;" and

WHEREAS, the Alaska DOT&PF's Highway Safety Improvement Program (HSIP) is intended to identify and fund highway safety projects that maximize lives saved and injuries eliminated per dollar spent; and

WHEREAS, the Alaska Department of Transportation and Public Facilities (DOT&PF) constructed two projects on Minnesota Drive at Benson and Northern Lights Boulevards, including the "Minnesota Drive: Tudor to 15<sup>th</sup> Avenue Pavement Preservation" and the "HSIP: Anchorage Pedestrian Lighting, Phase II;" and

NOW THEREFORE BE IT RESOLVED, the Spenard Community Council rejects the construction of the Minnesota Wall fence, which does not meet the vision for the neighborhood and does not address the pedestrian dangers at the Minnesota, Benson, and Northern Lights intersections; and

NOW THEREFORE BE IT FURTHER RESOLVED, the Spenard Community Council requests the following remedies for this project:

- Remove the center wall structure along Minnesota Dr. between Benson and Northern Lights Boulevard ASAP; and
- Work with community stakeholders and the public to design pedestrian improvements to add crosswalks to the "missing" sections (the fourth legs) at Minnesota Drive at both Benson and Northern Lights Boulevards; and
- Construct the pedestrian improvements ASAP.
