1 AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY TO
2 PROVISIONALLY ADOPT A NEW CHAPTER 21.06, DIMENSIONAL STANDARDS
3 AND MEASUREMENTS, AMENDING ANCHORAGE MUNICIPAL CODE TITLE 21
4 SUBJECT TO CONCURRENT FINAL PASSAGE AND APPROVAL OF ALL
5 PROVISIONALLY ADOPTED CHAPTERS OF TITLE 21.

8 WHEREAS, AR 2007-83 addresses the status of Title 21 chapters as provisionally
9 adopted by the Assembly; and

11 WHEREAS, provisional adoption is progressing as set out in AO 2006-172, as modified
12 by AO 2007-82; and

14 WHEREAS, Title 21, Chapter 21.06, *Dimensional Standards and Measurements*,
15 reviewed by the Title 21 Committee, is attached for further action by the Assembly:

17 NOW, THEREFORE, THE ANCHORAGE ASSEMBLY ORDAINS:

19 **Section 1.** Anchorage Municipal Code Chapter 21.06, *Dimensional Standards and*
20 *Measurements*, is hereby provisionally adopted as set forth in the attachment, and as
21 amended by action of the Assembly in this ordinance, following review and
22 recommendations from the Planning and Zoning Commission, and subject to revision as
23 the Assembly deems appropriate during concurrent final passage and approval of all
24 provisionally adopted chapters of Anchorage Municipal Code Title 21.

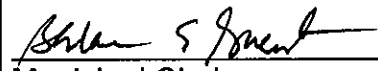
26 **Section 2.** In keeping with the purposes and intent set forth in AR 2007-83 and AO
27 2006-172 (as modified by AO 2007-82), Chapter 21.06, *Dimensional Standards and*
28 *Measurements*, as hereby provisionally adopted, shall not be deemed law of the
29 Municipality nor applied to land use matters until concurrent final passage and approval
30 of all provisionally adopted Title 21 chapters. Repeal of existing municipal code
31 necessary to effectuate such final passage and approval shall be implemented as
32 described by ordinance.

34 **Section 3.** This ordinance shall become effective immediately upon its passage and
35 approval by the Assembly.
