- ☐ Square footage of proposed outdoor use
- ☐ Temporary Structure Building Permit from Building Safety (if applicable)
- ☐ \$5,000 bond for temporary building permit (if applicable)
- ☐ A signed statement indicating:
 - This is a temporary use that shall be valid only until May 31, 2023, per AO 2022-68.
