No work is underway. This trail has been added to the Capital Project Needs List for evaluation and future funding consideration. Both Abbott Road and Hillside Drive are state owned facilities and funding would be from state or federal sources. The trail is not fully constructed between Rabbit Creek Road and the Seward Hwy. Construct missing trail links and reconstruct those in poor condition.

Hillside District Plan for Drainage Deleted

Substantial drainage analysis and inventory has been completed on the Hillside and a more detailed study of future needs will begin soon. A 2007 state grant request has been requested. Many areas on the Anchorage Hillside suffer from poor drainage. There are many unimproved roads that contribute to the drainage issues. No clear plan has been developed for the future. This project will complete a drainage study of the Anchorage Hillside area regarding existing and evolving drainage patterns and problem areas. The study is expected to identify and prioritize problem areas and capital projects to address the problems.
