Project scope: Construct drainage improvements in the Elmrich subdivision area. Project Status: The project has not started. State grant funding is proposed.

Oklahoma St Traffic Calming - Boundary Ave to 6th Ave

Cost: \$0

Funds on Hand: \$0

Additional funds required: \$0

Need: This need was identified by the Northeast Community Council.

Project scope: This project will construct traffic calming improvements on Oklahoma Street.

Project Status: This project has been added to the Traffic Calming needs list for future funding consideration through the Traffic Calming program.

Oklahoma St Surface Rehab - Boundary Rd to 4th Ave

Cost: \$1,000,000 Funds on Hand: \$0

Additional funds required: \$1,000,000

Need: Pavement and curbs are deteriorating on this collector route. The 2017 PCI survey rated the street in Satisfactory condition.

Project scope: This project will rehab the pavement and curbs as required.

Project Status: No work is underway or scheduled in the six-year Capital Improvement Program. The project will remain on the Capital Project Needs List for future funding consideration. The route is designated as a collector in the Official Streets and Highways Plan (OS&HP).

Duben Ave Upgrade - Muldoon Rd to Bolin St (12-32)

Cost: \$12,200,000

Funds on Hand: \$3,000,000 Additional funds required: \$9,200,000

Need: This is a strip paved road with inadequate drainage, pedestrian, and lighting facilities.

Project scope: Improvements are expected to include pavement, curbs, pedestrian facilities, street lighting, storm drains, and landscaping. The actual scope will be developed during the design phase which includes public involvement.

Project Status: 95% plans are being completed. Property acquisition negotiations underway. Construction schedule subject to funding. Muldoon intersection work will be completed with this project.

6

Nunaka Valley Area Lighting Improvements

Cost: \$800,000 Funds on Hand: \$0

Additional funds required: \$800,000

Need: A recent study of the Nunaka Valley area, which solicited extensive input from residents, revealed a need for additional street lighting as there are limited pedestrian facilities and a elementary school in the neighborhood.

Project scope: Install LED street lights in the Nunaka Valley Subdivision area.

Project Status: The project has not started. State grant funding is proposed.

7

Northeast Pedestrian Development Plan

Cost: \$90,000 Funds on Hand: \$0

Additional funds required: \$90,000

Need: The entire Northeast Community Council area has approximately 40% coverage with sidewalks, but additional sidewalks along school routes, connection between existing neighborhoods and the new Mall along Oilwell Road would benefit users and make safer neighborhoods.

Project scope: This funding will follow and implement the recommendations of the Anchorage Pedestrian Plan by looking in more detail to the sidewalk/pathway connections and safety improvements within neighborhoods and to the new developing commercial centers.

Project Status: No work is underway and no funding is proposed in the six-year Capital Improvement Program. The project will remain on the Capital Projects Needs List for future funding consideration.

8

11th Ave/12th Ave Area Road Reconstruction - east of Valley St (14-51)

Cost: \$4,000,000

Funds on Hand: \$140,000

Additional funds required: \$3,860,000

Need: The existing road way is experiencing frost heaves, pot holes, pavement cracks, and curb jacking. In some places the curb is more than six inches above the asphalt. There are no storm drains in these roads.

Project scope: Reconstruct 11th Avenue, 12th Avenue, and Laplander Place. Improvements are expected to include a new road base, storm drain installation, and upgraded lighting.

Project Status: Survey and soils have been completed. Year of construction is dependent on the availability of funding. Design study was funded with a 2014 state grant.

9

Gilmore and Prosperity Estates Subd Area Road Resurfacing (14-52)

Cost: \$2,000,000 Funds on Hand: \$60,000

Additional funds required: \$1,940,000

Need: The roads in these subdivisions to the west of Beaver Place are experiencing frost heaves, cracking, pot holes, and curb jacking. The trail from More Lane to Prosperity Drive has been overgrown with vegetation.

Project scope: Resurface the roadways with digouts where needed to reestablish a solid road base. Replace curb as needed. Remove vegetation and resurface trail from More to Prosperity.

Project Status: Design study was funded with a 2014 state grant. Year of construction will depend on availability of funding. No survey or soils required.

10

Northeast District Traffic Circulation and Safety Study

Cost: \$360,000 Funds on Hand: \$0

Additional funds required: \$360,000

Need: The East Anchorage District Plan will provide an importantly review of the transportation circulation and safety need for the area, however the necessary funding to support an in-depth and complete analysis is lacking. This study will support that effort and bring recommendation and priorities.

Project scope: This effort will focus on the traffic circulation and safety impacts of the new commercial developments at the northeast regional mall and the growing Creekside Town Center. The scope of the transportation circulation and safety study is to focus on the coordination of the future streets in the study area, with particular interest of connectivity between subdivisions, where applicable. The plan will also identify potential traffic related problems that may occur as a result of land use development related to location and density with recommendations to address those concerns. The study scope is expected to focus on the residential street network within neighborhoods. The result is expected to provide better neighborhood internal circulation which could lessen the burden of arterial streets carrying localized traffic needs.

Project Status: No work is underway and no funding is proposed in the six-year Capital Improvement Program. The project will remain on the Capital Projects Needs List for future funding consideration.

Four Seasons Mobile Home Park Area Storm Drain Improvements

Cost: \$2,000,000 Funds on Hand: \$0

Additional funds required: \$2,000,000

Need: According to an investigation by Street Maintenance, the bottom of this 48" pipe is rotting out and the top is pulling down in many spots.

Project scope: Replace the storm drain from East 4th Avenue on Newell Street to the manhole northwest of Peppertree Loop.

Project Status: The project has not started. Bond funding is programmed.

Foothills Subdivision Area Road Reconstruction

Cost: \$7,000,000 Funds on Hand: \$0

Additional funds required: \$7,000,000

Need: State Street, Greendale Drive, and Northview Drive lack adequate drainage. Residents are experiencing water issues and the surface of the road is deteriorating. Many of these streets were rated Condition E and F in the 2014 GASB survey.

Project scope: Improvements are expected to include a new road base with fresh pavement, storm drains with curb and gutter, and street lights.

Project Status: No work is currently scheduled in the 6-year Capital Improvement Program. Funding will be through the 90/10 Road Improvement District program in which the project is initiated by property owners who agree to pay 10% of the costs through special assessments.

Staedem Dr Traffic Calming

Cost: \$25,000 Funds on Hand: \$0

Additional funds required: \$25,000

Need: This project was identified by the Northeast Community Council.

Project scope: This project would design and construct traffic calming improvements on Staedem Drive.

Project Status: No work is underway or scheduled in the six-year Capital Improvement Program. The project will remain on the Capital Projects Needs List for future

funding consideration.

Elmrich Subdivision Area Traffic Calming

Cost: \$50,000 Funds on Hand: \$0

Additional funds required: \$50,000

Need: Local residents are concerned about high speeds of motorists and cut-through traffic.

Project scope: This project will construct traffic calming improvements in the Elmrich Subdivision area including Trafford Lane, Dickerson Drive, 2nd Avenue, and Fern

Street.

Project Status: No work is underway and no funding is proposed in the six-year Capital Improvement Program. The project has been added to the Traffic Calming

Needs List for future funding consideration.

Patterson St Surface Rehab - DeBarr Rd to 20th Ave

Cost: \$2,000,000 Funds on Hand: \$0

Additional funds required: \$2,000,000

Need: Pavement and curbs are deteriorating on this collector route. The 2017 PCI survey rated the street in Satisfactory condition.

Project scope: This project will rehab pavement and curbs as required. Installation of traffic calming and pedestrian improvements may be included.

Project Status: No work is underway or scheduled in the six-year Capital Improvement Program. The project will remain on the Capital Project Needs List for future funding consideration. The route is designated as a collector in the Official Streets and Highways Plan (OS&HP).

Boundary Ave Surface Rehab - Oklahoma St to Muldoon Rd

Cost: \$1,500,000 Funds on Hand: \$0

Additional funds required: \$1,500,000

Need: The surface of the roadway has deteriorated to the point that maintenance is no longer cost effective.

Project scope: Resurface Boundary Avenue and bring pedestrian facilities into ADA compliance. Project Status: The project has not started. Bond funding is proposed for design and construction.

Patterson St Bike Lanes - Debarr Rd to Chester Creek (18-13)

Cost: \$300.000

Funds on Hand: \$300,000 Additional funds required: \$0

Need: The Anchorage Bicycle Plan identifies the need for bike lanes on Patterson. Project scope: Install bike lanes on Patterson Street from Debarr Road to Chester Creek.

Project Status: 2018 road bonds provided for a design start.

Project Status: This is an annual program to pave 10-12 alleys each summer in the Anchorage Roads and Drainage Service Area (ARDSA).

Golden Bear Dr Resurfacing

Cost: \$250,000 Funds on Hand: \$0

Additional funds required: \$250,000

Need: The roadway is showing signs of excessive wear and pot holing. The Northeast Community Council would also like to see pedestrian facilities added.

Project scope: Resurface the road and evaluate the need for pedestrian facilities.

Project Status: The project has not started. There is no funding programmed in the current six-year CIP. The project will remain on the Needs List for future funding

consideration.

Forest Health and Park Safety

Cost: \$200,000 Funds on Hand: \$0

Additional funds required: \$200,000

Need: In September of 2012 more than 5000 trees were lost during a windstorm. Initial assessments estimate clean-up to be over 1 million dollars. The Anchorage Urban Forester's plan to address the damage include a mix of volunteer clean-up, commercial sales and contracted clean-up. Currently, park assets are safe for park and trail users, however as conditions change, follow-up risk assessment and clean-up is required.

Project scope: Funds will be used to conduct a follow-up risk assessment, develop a recommended strategy for species management (cottonwood, evergreen, birch), finalize a tree emergency plan and continue the clearing of hazard trees on parkland from the 2012 windstorm.

Project Status: Park Maintenance and horticulture crews have cleared parks and trails making current park assets safe for Anchorage citizens.

8

Turpin Park Playground

Cost: \$200,000 Funds on Hand: \$0

Additional funds required: \$200,000

Need: Turpin Park is an important playground for the Northeast Anchorage neighborhood. The playground and safety surfacing need to be compliant with current industry-wide safety standards.

Project scope: Funds will be used to repair the playground and safety surfacing and fix neighborhood park amenities.

Project Status: Park Maintenance performs monthly safety inspections and repairs the park assets as necessary.
