1 Sylvan Dr Reconstruction - Fairweather Dr to Old Seward Hwy (13-43)

Status: Apr 13 2015 - A 2013 state grant has funded design. State grant funding is proposed for construction. Public scoping meeting was held last fall. There is strong community support for the project.

92nd Ave Extension - King St to Old Seward Hwy

Status: Apr 13 2015 - This project has not started. State grant funding is proposed.

3 92nd Ave Extension - Minnesota Dr to King St

Status: Apr 13 2015 - No work is currently scheduled in the 6-year Capital Improvement Program. The project will remain on the Capital Project Needs List for future funding consideration.

Mentra Cir Area Drainage Improvements (13-60)

Status: Apr 13 2015 - An RFP is being developed.

Status: Apr 13 2015 - No work is currently scheduled in the 6-year Capital Improvement Program. Funding will be through the Road Improvement District program in which the project is initiated by property owners who agree to pay 70% of the costs through special assessments.

64th Ave Upgrade - Greenwood St to Homer Dr

Status: Apr 13 2015 - The project has not started. This project will become viable after the Alaska DOT installs storm drains in Homer Drive as part of the Seward Highway widening project.

Status: Apr 13 2015 - No work is currently scheduled in the 6-year Capital Improvement Program. Funding will be through the Road Improvement District program in which the project is initiated by property owners who agree to pay 70% of the costs through special assessments.

12 76th Ave Reconstruction - King St to Old Seward Hwy

Status: Apr 13 2015 - State grant funding is proposed for design.

13 80th Ave/Greenwood St Area Water Quality Improvements

Status: Apr 13 2015 - No work is underway on this project. Significant public involvement and coordination with Parks and Recreation is planned.

14 Old Seward Hwy/International Airport Rd Area Storm Drain Improvements

Status: Apr 13 2015 - The storm drain pipes in this area are scheduled to be videoed in 2015. The project scope will be created from the results of the video.

15 Arctic Blvd Extension/Upgrade - Dimond Blvd to 92nd Ave

Status: Apr 13 2015 - This project has not started. Funding is proposed as a partnership with local road bonds and state grants. This road is classified as a collector in the Official Streets and Highways Plan (OS&HP).

Status: Apr 13 2015 - This is an annual program with bond funding anticipated.

1 Minnesota Dr East-side Frontage Rd - Raspberry Rd to Dimond Blvd

Status: Apr 13 2015 - No work is underway or scheduled in the six-year Capital Improvement Program. This is a state-owned facility and evaluation and funding would be by the State of Alaska.

2 Seward Hwy at 92nd Ave Grade Separation - Old Seward Hwy to Abbott Rd

Status: Apr 13 2015 - Design is funded and underway by the State of Alaska. The State project has three main components: a) An underpass at 92nd Ave, b) upgrading 92nd Ave (Abbott Rd) west to the Old Seward Hwy, and c) upgrading 92nd Ave (Academy St) east to Vanguard Dr. The western section will be constructed first. Construction is anticipated in 2018 depending on the availability of funding. The other sections may be constructed in conjunction with the upgrade of the New Seward Highway.

3 Seward Hwy Expansion - Dimond Blvd to OMalley Rd

Status: Apr 13 2015 - A major investment study has been completed by the State of Alaska. Public involvement is underway. This is a state-owned facility and evaluation and future funding would be by the State of Alaska.

4 Seward Hwy Expansion - Dowling Rd to Dimond Blvd

Status: Apr 13 2015 - A major investment study has been completed by the State of Alaska. Public involvement is underway. This is a state-owned facility and evaluation and future funding would be by the State of Alaska.
