Department: Fire

Department Goal:

The goal of the Fire Department of the 1988-1993 CIP is to provide effective and efficient emergency operations, fire suppression, and emergency medical capability through replacement of older fire apparatus and medic units and establishment of an improved emergency telecommunications network. An analysis of fire protection needs in the Eagle River Valley and South Fork areas is currently underway. When the plan is presented for review and approval, any capital requirements will be recommended as amendments to the CIP.

Anchorage Fire:

The \$3,040,000 in requested general obligation bond funds for the 1988-1993 CIP will provide for necessary replacement of aged fire apparatus, equip the new emergency telecommunications network and provide emergency generators for fire stations. The age of most first line pumper/tanker vehicles will be at or under a maximum age of 12 years.

Chugiak Fire:

Requested local funding of \$861,000 will provide necessary replacement of aged equipment.

Emergency Medical Services:


The \$848,000 in general obligation bond funds in the 1988-1993 CIP will provide replacement of medic units to sustain emergency medical services capability.




