

STATE ROADWAY IMPROVEMENTS

Program Statement

This section of the 2008-2013 Capital Improvement Budget/Program identifies transportation improvement projects for State-owned roads that are:

- Reflected in years 2007-2008 in the Approved 2006-2008 Transportation Improvement Program, and projects included in the illustrative program for years 2009-2011; and
- Other needed improvements to State roadways in the Municipality.

Since State Roadway projects are the responsibility of State Department of Transportation and Public Facilities, the amounts and sources of funds for these State roads have not been included in the 2008-2013 CIB/CIP financial summaries or as part of the anticipated appropriation documents prepared for Assembly approval.
