A RESOLUTION ADOPTING THE 1969 BUDGET FOR THE CITY OF ANCHORAGE, ALASKA  
AND APPROPRIATING MONIES FOR THE 1969 BUDGET

Whereas, the City Manager has prepared his proposed 1969 budget for the City of Anchorage, Alaska, and has presented the budget to the City Council in accordance with Section 6.2 of the City Charter; and

Whereas, the City Council reviewed the budget as presented and made various changes therein; and

Whereas, a notice of the public hearing was published as required by Section 6.3(b) by the City Clerk one week prior to the date of hearing; and

Whereas, on December 3, 1968, at a special meeting of the City Council a public hearing was held on the budget as revised in accordance with Section 6.3 of the City Charter; and

Whereas, the 1969 budget is ready for adoption.

NOW, THEREFORE, THE CITY OF ANCHORAGE RESOLVES:

Section 1. That the 1969 budget for the City of Anchorage as prepared by the City Manager and revised by City Council be and the same hereby is adopted as the 1969 budget of the City.

Section 2. That the amounts as set forth in the 1969 budget as revised by City Council for the respective departments shall be and they hereby are appropriations for the 1969 fiscal year.

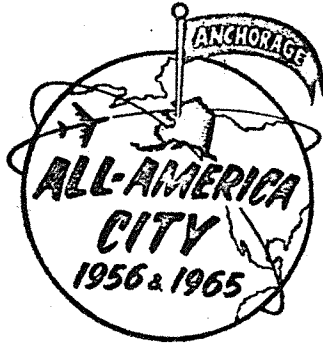
Publication of this resolution shall be made by posting a copy hereof on the City Hall Bulletin Board for a period of ten (10) days following its passage and approval.
