In April 2018, voters approved the pending sale of one of our utilities, Municipal Light & Power. 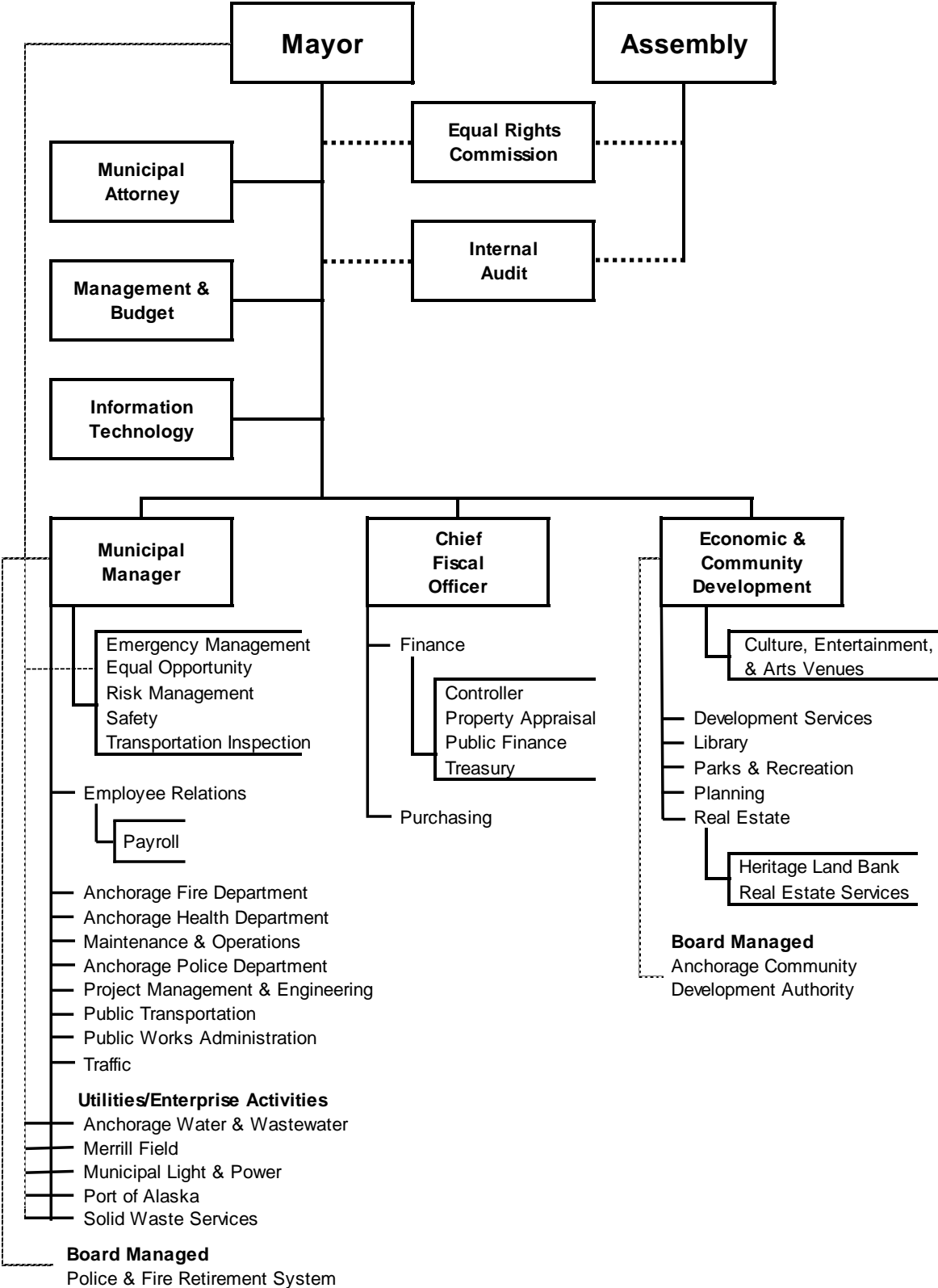
