2. <u>Minutes from the April 26, 2018 Meeting</u>:

Ms. Sinnott made a motion to approve the minutes. Motion was seconded by Ms. Jackson. The minutes were approved as written.

5. Standing Reports:

Anchorage Animal Care and Control (AACC) Monthly Report and Public Outreach

Dr. Wilson reported on April 2018.

A total of 407 animals were received during April compared to 381 animals received during April 2017. The total number of animals received year-to-date as of the end of April is 1,356. The April cat claim rate was 18% and the cat adoption rate was 70%. The April dog claim rate was 77% and the dog adoption rate was 79%. During the month of April there were 472 dog licenses sold and the total number of dog licenses sold year-to-date was 1,792. The total number of requests for service during April was 487. The total number of requests for service was 1,485 year-to-date. There were 7 classifications made during April. The total number of Notice of Violations (NOVs) issued during April was 130 and a total of 317 for the year. There were 45 animal bites during April compared to 59 during April 2017. A total of 163 animal bites year-to-date. Dr. Wilson clarified this is only bites to humans and dos not include animal-on-animal bites.

Ms. Jackson pointed out that when an animal bites a human or kills another animal and is classified the animal is required to be on a muzzle. She asked if that would apply to a cat and not just dogs. Dr. Wilson stated that while classifications are predominately dogs,

there is currently a cat at Animal Control that escaped from the owner's apartment and went into a neighboring apartment and killed two parakeets. If claimed the cat would be subject to all the restrictions of a classified animal, in this case a level four, and if the owner want to have the animal reclassified after the required minimum period of time, the animal would have to have completed obedience school. There has been only one other cat classified during Dr. Wilson tenure and that was a cat classified as a level one for continually chasing a dog. Any owner can appeal a classification decision.

- Presented dog bite prevention to 154 students at Oceanview Elementary over two days.
- A total of 876 students for the month.
