# **VII Municipal Reports**

Susan Shiffer, Public Transportation – Ms. Shiffer introduced, Abul Hassan, the new Public Transportation Operations Superintendent. The AnchorRides program has new MV1 vehicles in operation. A wheel chair sits in the passenger side of the front of the vehicle. The next order placed by Public Transportation for new vehicles will be for the larger vehicles. Project Action has handouts regarding service animals that you can order free of charge, may be helpful to the Commission.

# **VIII Updates from Chair**

David Ziemer, Chair – Rim Architects is working on two large projects in public buildings in Anchorage that are updating the restroom facilities to be up to date and into compliance with ADA Law.

## **IX Old Business**

Service Animal Sub-Committee Update – This sub-committee did not meet yet. They need to schedule a meeting. Ms. Koral is part of a National organization on service animals and has been tasked with researching all the State Laws on service animals. She will bring the laws that can be used to assist with drafting the Municipal ordinance to the attention of the sub-committee when available.

Draft Letter to the Assembly – Mr. Ziemer will have draft out by email by the end of the week for Commissioner review.

Title 21 Parking Recommendations – Assembly member Traini requested the ADA Advisory Commissions recommendations for updating accessible parking section of Title 21. Mrs. Troxell provided the current Title 21 language on accessible parking to the Commissioners for their review. Mr. Barton recommended that page 7-111 number 11 be updated to the 2010 ADA law. Mr. Ziemer recommended that the language be updated to read the most current version of the ADA law that is being enforced. Mrs. Troxell is tasked with inviting Erika McConnell, Community Development Planning Manager, to the November meeting. Commissioners that would like to offer individual feedback regarding their recommendations to update the section of Title 21 on the accessible parking should send them by email. David Barton & David Ziemer volunteered to meet and complete a review of the section and draft recommendations.

Universal Design for Accessible Taxis – There was a recent court case in New York regarding this issue. The resolution of the case is that 50% of the taxis in New York must be accessible taxis. The issue is defining what the specification of an accessible cab. Mr. Barton suggested that the Commission research the specification that will be used in New York and recommend the same specifications in Anchorage. Mr. Barton will research this before the next meeting and make recommendations to the Commission at the next meeting.

Facebook Public Education Campaign – October 2014 – October material is not ready for review at this time. Mrs. Troxell will draft a proclamation and email to Commissioners for review/approval for National Disability Employment Awareness Month.

Public Comment Meeting – November 2014 – The Commissioners would like to push the date for the public meeting out to January 2015 and ask the Senior Commission to co-host the meeting. A suggestion was made to have a public comment period in addition to the meeting and take input via a variety of different sources. If the Senior Commission is willing to participate in the meeting we could ask to add the announcement of the meeting to the Senior Voice. The preferred meeting locations would be either the Lousac Library or the Anchorage Senior Center. Ms. Davis will coordinate with the Senior Commission to find out if they want to partner for the meeting. The topics of the meeting will be service animals, housing, transportation and other barriers to independence and full community access.
