- Have harm reduction supplies (drug disposal kits, medication storage locks, naloxone, etc) and a fact sheet/info card for attendees to take with them when they leave
- Future townhalls: have APD present their data, do small focus groups to get feedback from citizens (maybe partner with UAA), townhall with Anchorage School District about opioids and naloxone in schools
- Open Discussion
 - Elderly opioid use folks who have opioids in their house should be educated about proper storage and disposal to prevent misuse by others, recognize signs of an overdose
 - ANTHC hosted a drive thru event for naloxone kits and training that was very successful, had over 500 people get trained
 - Attendees were curious about how to get the Anchorage Assembly and Administration more involved and AHD Director Rash stated she provides updates about the AOTF at the monthly Health Policy Committee meetings and the administration is on the AOTF emails. AHD will continue to seek out participation and involvement from assembly members and members of the administration.
 - Adolescent youth who use substances do more promotion of 988 (suicide prevention hotline)
 - In other states, pharmacists hand out a naloxone kit when they fill an opioid prescription above a certain dose
 - Alaska Native Medical Center pharmacy hands out a naloxone kit to anyone who comes to the pharmacy and would like one (people do not have to be a patient at ANMC)
 - Encourage organizations to incorporate naloxone training as part of their onboarding process
 - Harm reduction vending machines; funding is available through specific grant to place these in law enforcement offices
 - IKnowMine.org has lots of resources people in AK can order and training videos
 - Vending machines provide data about use
 - Project Hope anticipating a funding gap which will likely impact their ability to provide naloxone kits as widely as they are now. Still to be determined what that funding gap will be and they will keep the group updated.
