#### Grants Status report:

<u>State of Alaska, Capital Budget</u>: Thank you to Alaska Trails for including the suspension bridge to replace the Hand Tram in their requests for funding of the State of Alaska. State has awarded \$1.2M for this project as part of Alaska Long Trail Funding. Construction goal is 2024/2025.

<u>Rasmuson Tier II Grant</u>: GVSA has reapplied for funding for this project now that we are nearing our funding goal. <u>Alaska Community Foundation Trail Care Grant</u>: GVSA applied for \$2451 for trail tools for volunteer projects and were awarded \$2032.

KMTA 2024 Grant cycle: No grant cycle in early 2024. Pending info on next grant cycle

<u>Recreational Trails Program Grant (RTP)</u>: GVSA submitted RTP grant application for work on Middle INHT Oct 31. Progress through the ORTAB was positive, pending hearing final outcome.

<u>Dugan Family donation</u> for trails signs on Middle Iditarod Trail and bench at the 5K parking are nearing completion. Remaining is the trail sign that will be produced and placed.

Dugan Family donation for reconstruction of 2 bridges on the Middle Iditarod Trail. We'll start to work on this in the spring.

**Trail Map Project:** Staff received a rough draft from the graphic designer and met with maps committee in December and February. Staff and committee are working through changes with the contractor.

Trails Commercial Use Permits: 2024 permits are being issued.

# BLM Hosting Public Listening Sessions for Alaska Long Trail National Scenic Trail Feasibility Study

The Bureau of Land Management invites the public to attend upcoming listening sessions to inform a congressionally-directed feasibility study of the proposed Alaska Long Trail National Scenic Trail. The BLM will host these public, in-person meetings the week of April 8 in Anchorage, Seward, Wasilla, Cantwell, and Fairbanks.

These listening sessions provide BLM the opportunity to share more information about the study process and gather input on this proposed National Scenic Trail, including information about potential trail routes.

The BLM is analyzing the feasibility, suitability, and desirability of designating the route as a national scenic trail as directed by Congress. Public input is critical to this study. Once completed, the feasibility study will be transmitted to Congress, which has the sole authority to enact legislation to designate new national scenic trails.
