Project: PRC 2017-17: Campbell Creek Trail Improvements

INTRODUCTION & BACKGROUND

The Campbell Creek Trail improvement project is part of a multi-year, comprehensive trail maintenance program aimed at addressing safety and improving user experience on Parks and Recreation maintained trails. Funding is provided by the 2016 and 2017 Municipal Bonds for approximately \$1.35 million and a 2015 State Legislative Grant for \$150K. With this funding Parks and Recreation will be addressing several elements including: rehabilitation or replacement of cracked and heaving asphalt, bridge transitions, amenity upgrades and improved signage and wayfinding.

PLANNING AND PUBLIC INVOLVEMENT

The Parks and Recreation Department has collected the community's feedback through the previous years of construction improvements on the Greenbelt Trail System. Staff has been collecting comments from the Trail Watch user group and conducted numerous site visits with users and other State and Federal Agencies to identify the highest priority maintenance repairs. In March of 2017, the project was presented to the Taku/Campbell Community Council. The feedback was entirely positive, in-favor of the project and phasing plan.

PROJECT PLAN

PHASE 1: SPRING 2017 IMPROVEMENTS

Staff has identified the *highest used* portion of the trail corridor and will begin construction in this region. **Phase 1 construction will include:**

Campbell Creek Trail between **West Dimond BLVD. to Minnesota Dr.** is an 8 ½ foot-wide asphalt multiuse recreation trail. The proposed project will repave and reconstruct the existing trail, while adding two (2) feet of soft-surface shoulders on each side of the asphalt. This improvement project will include the rehabilitation/replacement of cracked and heaving asphalt, streambank restoration, bridges, underpasses, amenity upgrades and improved signage and wayfinding.

PHASE 2: 2017-18 IMPROVEMENTS

Staff has identified the *highest priorities* of concern by segment, spur and hazard.

Phase 2 construction will include:

Campbell Creek Trail between **Minnesota Dr. to Arctic BLVD.** is an 8 ½ foot-wide asphalt multi-use recreation trail. The proposed project will repave and reconstruct the existing trail, while adding two (2) feet of soft-surface shoulders on each side of the asphalt. This improvement project will include the rehabilitation/replacement of cracked and heaving asphalt, streambank restoration, bridges, underpasses,

amenity upgrades and improved signage and wayfinding. This phase will likely begin mid-July to early August 2017, permitting dependent. It is likely that the project will reach substantial completion by October 2017.

WHEREAS, the Anchorage Parks and Recreation Commission serves in an advisory capacity to both the Mayor and the Assembly; and

WHEREAS, the Campbell Creek Trail is major multi-use trail corridor that connects areas within our community and provides valuable recreational benefits in a protected greenbelt; and

WHEREAS, Phase 1 will focus on the area of trail between West Dimond Blvd. and Minnesota Drive and Phase 2 will focus on the area of trail between Minnesota Drive and Arctic Blvd.; and

WHEREAS, the proposed improvements include rehabilitation/replacement of cracked and heaving asphalt, streambank restoration, bridges, underpasses, amenity upgrades and improved signage and wayfinding, as well as the addition of two (2) feet of soft-surface shoulders on each side of the asphalt, and

WHEREAS, this project is supported by the Taku-Campbell Community Council;

NOW THEREFORE BE IT RESOLVED that the Anchorage Parks and Recreation Commission approves the proposed rehabilitation of the Campbell Creek Trail as presented.




Phase 1: West Dimond BLVD. to Minnesota Dr.
