## Employment Services

To all Election Workers,

Pursuant to Internal Revenue Service guidelines, Election Workers are considered employees. Based on these guidelines, the Municipality of Anchorage, Employee Relations Department, is requiring anyone that will be working and receiving compensation for work performed during the upcoming election complete a new I-9 form.

Employers are required to hire only persons who may legally work in the United States. In order to accomplish this task, an I-9 form is required to verify the identity and employment eligibility of anyone hired by the Municipality.

Staff will be available at the training facility prior to, during, and after each of the training sessions to assist with completing the I-9 Forms. To complete this task as efficiently and accurately as possible please bring with you documents that establish identity and employment eligibility. If possible, fill in Section 1 in advance and please write legibly.

Attached to this letter is a list of acceptable documents.

To establish both identity and employment eligibility a person can present a passport, an Alien Registration Receipt Card, or one of the other documents from List A.

If a person does not present one document from List A, he or she must present **two** documents - one from List B, which establishes identity, **and** one document from List C, which establishes employment eligibility.

I would like to thank you in advance in assisting us in completing the requirements asked of us as an employer by the Federal Government.
