9 **Section 1.** Anchorage Municipal Code section 4.05.155 is hereby amended to read as

12 **4.05.155 Assembly notification.**

14 **A.** All boards and commissions established under this title, and members
15 thereof, shall be listed and named in an informational memoranda submitted
16 to the assembly annually by the mayor at the first meeting during the month
17 of October.

19 1. To the extent the information is voluntarily provided by appointed
20 members, the informational memoranda shall include a summary of
21 the composition, in the aggregate, of all boards and commissions by
22 gender, ethnic diversity, and disability.

26 **Section 2.** This ordinance shall be effective immediately upon passage and approval

13 describe themselves as members of an ethnic minority or experience a disability. This
14 information is provided to the Municipality on a voluntary basis, and an annual update to
15 the Assembly provides an occasion for the Municipality as a whole to review its progress
16 towards the stated goal of increasing diversity on Municipal boards and commissions.
