1 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE  
2 HUNDRED FIFTY SEVEN THOUSAND EIGHT HUNDRED TWENTY NINE DOLLARS (\$157,829)  
3 FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION & PUBLIC  
4 FACILITIES; AND APPROPRIATING TWO THOUSAND NINE HUNDRED TWENTY TWO  
5 DOLLARS (\$2,922) AS A CONTRIBUTION FROM THE 2008 ANCHORAGE POLICE OPERATING  
6 BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE  
7 CATEGORICAL GRANTS FUND (231) ANCHORAGE POLICE DEPARTMENT, FOR IMPAIRED  
8 DRIVING ENFORCEMENT.

10 THE ANCHORAGE ASSEMBLY RESOLVES:

11  
12 Section 1. That ONE HUNDRED FIFTY SEVEN THOUSAND EIGHT HUNDRED TWENTY  
13 NINE DOLLARS (\$157,829), is appropriated from the State of Alaska, Department of Transportation &  
14 Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for Impaired  
15 Driving Enforcement.

17 Section 2. That TWO THOUSAND NINE HUNDRED TWENTY TWO DOLLARS (\$2,922) is  
18 appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2008 Anchorage Police  
19 Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage  
20 Police Department.

22 Section 3. This resolution shall take effect immediately upon passage and approval by the  
23 Anchorage Municipal Assembly.

4 **Subject:** Appropriation from the State of Alaska, Department of Transportation & Public  
5 Facilities, of an Impaired Driving Enforcement Program Grant and local  
6 match required. (\$160,751)  
7

8 The Municipality of Anchorage has received a grant from the State of Alaska, Department of  
9 Transportation & Public Facilities, in the amount of \$157,829 for a DUI .08 Impaired Driving  
10 Enforcement program. This grant is intended to support focused enforcement during the period April 1,  
11 2008 through September 30, 2008.  
12

13 This grant will be used to pay officer overtime for traffic assignments specifically targeted for  
14 enforcement of Impaired Driving violations within the Municipality of Anchorage. Through increased  
15 awareness and enforcement of Impaired Driving offenses, the citizens of Anchorage will experience safer  
16 roads and reduced traffic accident injuries.  
17

18 A special condition of this grant is that the department provides matching funds. The total projected  
19 Municipal cost is \$2,922, which has been budgeted in the 2008 Police Operating Budget. This grant  
20 begins on April 1, 2008 and will end on September 30, 2008.
