Thanks for your interest in participating in the Anchorage Share-A-Ride Vanpool Program. Our van pool program is available to Southcentral commuters who prefer not to drive alone. Car/vanpools provide an economical alternative to driving alone and also help to keep Anchorage's air cleaner and to reduce traffic congestion.

Van Poolers ride in our luxury 13 passenger vans, with seats similar to those in airplanes. Each seat reclines and has a reading light. Van pools are organized by home and work locations and similar work hours. The eligibility criteria are that a van has space available for a new rider, the van pool driver approves the rider joining the van and all paper is completed and submitted to Share-A-Ride.

This form is to be used to register for the Share-A-Ride Program, apply to ride in specific van pool and to give notice to leave a specific van pool. Please check the box corresponding to appropriate form.

- Application to Ride In a Van Pool** – check this box when you have already registered in the Share-A-Ride Program and you have been accepted to be in a van pool. A commuter cannot begin riding in a van until this form has been completed, submitted to Anchorage Share-A-Ride and approved.
- Notice to Leave Pool** – check this box when you are unable to continue to ride in a van pool. All riders must submit this notice 30 days prior to the actual date they will discontinue riding in the van.
