**BEVERAGE DISPENSARY LIQUOR LICENSE
FOR DAVE AND BUSTERS OF ALASKA, INC.**

LOCATION AND DESCRIPTION OF PLANNED USE

Dave & Busters of Alaska, Inc. is making application for a special land use permit for allowing “on premises” alcohol sales for Dave & Busters, which is located at 800 E. Dimond Blvd., Ste. 220, Anchorage, Alaska 99515. The use of this location in the Dimond Mall for a family restaurant, bar, and interactive game business is consistent with the Anchorage Central Business District Comprehensive Development Plan and the Anchorage 2020 Comprehensive Plan as set out in the policies discussed below. The Taku-Campbell Community Council has already unanimously approved the site for a Dave and Buster’s facility.

1. The proposed use is consistent with the comprehensive plan and all applicable provisions of this title and applicable state and federal regulations:

The proposed use for Dave & Busters is consistent with the comprehensive plan and all applicable provisions of this title and applicable state and federal regulations.

2. The proposed use is consistent with the purpose and intent of the zoning district in which it is located, including any district specific standards set forth in chapter 21.04.

The proposed use for a Dave & Busters is consistent with the purpose and intent of the zoning district in which it is located on E. Dimond Blvd. and will conform to the Taku/Campbell Area Development Plan and all standards set forth in Chapter 21.04

3. The proposed use is consistent with any applicable use-specific set forth in Chapter 21.05.

Dave & Busters will be located on E. Dimond Blvd. inside the Dimond Mall. The restaurant will conform to the Taku/Campbell Area Development Plan and the Anchorage 20/20 Comprehensive Plan by adding a restaurant that is allowed to serve beer and wine. The result of adding a restaurant and

bar with alcohol service in this area will help to create more of a multi-use center of commerce that is the core vision of the Anchorage Central Business District Comprehensive Development Plan. Dave & Busters will be using an area inside of the mall that will be attractively developed and well-suited to take on all the needs of both the business itself and local residents and visitors.

4. *The site size, dimensions shape, location, and topography are adequate for the needs of the proposed use and any mitigation needed to address potential impacts.*

See attached diagram and site plan. Dave and Buster's believes that the facility is the perfect size for the needs of the proposed use and any mitigation needed to address potential impacts.

5. *The proposed use will not alter the character of the surrounding area in a manner which substantially limits, impairs, or prevents use of surrounding properties for the permitted uses listed in the underlying zoning district.*

Dave & Busters location is adjacent to an area referenced in the Land Use Policy Map as a at this location is consistent with the goals and policies of the Anchorage 2020 Comprehensive Plan. This location is in the proximity of the Dimond Center Mall and a variety of retail and restaurant businesses on Dimond Blvd. This location is also near what the Anchorage 20/20 Plan calls a *Transit-Supportive Development Corridor*. Arctic Blvd. is the corridor identified in the Plan. These corridors represent optimal locations for more intensive commercial and residential land use and development which will support and encourage higher levels of transit service. The addition of a restaurant and liquor license in close proximity to this corridor furthers the goals and policies of the 2020 Plan by providing the convenience of additional options for full service dining facilities to the traveling public and the residents of future medium-high density housing developments which are planned along these corridors.

6. *The proposed use is compatible with uses allowed on adjacent properties, in terms of its scale site design, operating characteristic (hours of operation, traffic generation, lighting, noise, odor, dust, and other external impacts).*

Dave & Busters is compatible with uses allowed on adjacent properties in terms of its scale site design, operating characteristics, and

uses. The Dimond Mall houses many diverse tenants and businesses and has welcomed Dave and Buster's to its facility.

7. Any significant adverse impacts anticipated to result from the use will be mitigated or offset to the maximum extent feasible.

NONE. However, should unanticipated adverse impacts occur at any time, Dave and Buster's is committed to operating a lawful and neighborly business and will seek to minimize such negative impact on the community. Dave and Buster's has a lengthy track-record around the country and believes that the Alaska facility will be as warmly received and successful as its' other facilities.

8. The proposed use is appropriately located with respect to the transportation system, street capacity, access to collectors or arterials, connectivity off-site parking impacts, transit availability impacts on pedestrian, bicycle, and transit circulation, and safety for all modes.

The proposed use is appropriately located with respect to all aspects of the local transportation system. The facility is located on E. Dimond Blvd. and therefore is located in the Dimond Mall. As such, the facility has ample parking, ample traffic circulation, and has immediate access to a regular bus route.

9. The proposed use is appropriately located with respect to existing and or planned water supply, fire and police protection, wastewater disposal, storm water disposal and similar facilities and services.

The following public services are currently existing at Dave & Busters location:

1. Public utilities (sewer and water, waste collection, electricity, natural gas).
2. Police and Fire protection as provided by the Municipality of Anchorage.

There are no additional infrastructure requirements for any public services or facilities.

Public Safety

What are the proposed precautions to maintain order and prevent unlawful conduct at the licensed premises?

Inside Facility:

All Dave & Busters servers will be TAM certified. Employees will be instructed to ask for the identification of all persons appearing to be under 30 years of age. Employees who violate this policy will be disciplined progressively and/or terminated and will be instructed so upon employment. Further, managers and all servers will be trained and reminded to assess the condition of drinkers as enumerated in the TAM training to prevent the service of alcohol to drunken persons.

Outside Facility:

Further, for the protection of patrons in the parking lot, Dave & Busters employees and/or employees of the Dimond Mall itself will patrol the parking lot, as needed, to ensure the minimization of loitering. My client will work with surrounding tenants, neighbors, neighboring community councils and service patrols to combat any problems which arise in or near the facility. Both inside and outside of the facility will have sophisticated video-security systems which will also be used to prevent and deter crime.
