DISMISSAL OF APPEAL

WHEREAS, the State of Alaska Department of Transportation and Public Facilities (DOT&PF) filed a site plan review application dated May 27, 2015 for transportation project site plan review approval for a new roadway through the U-Med District; and

WHEREAS, the project is identified on the application as Northern Access to U-Med District #51838, to be reviewed under "New" Title 21; and

WHEREAS, on October 25, 2015, the Municipality of Anchorage Planning and Zoning Commission held a public hearing; and by Planning and Zoning Commission Resolution No. 2015-041, the draft design study report was approved with amendments on November 2, 2015; and

WHEREAS, AMC 21.03.190B.4.c provides that decisions may be appealed to the Board of Adjustment; and

WHEREAS, Notice of Appeal dated November 22, 2015 was filed and accepted as timely by the Municipal Clerk on November 23, 2015; and

WHEREAS, by letter dated April 26, 2016, DOT&PF notified the Board of Adjustment it was honoring a request by Anchorage Mayor Berkowitz to cease all activities related to this

site plan review, and that in light of the project's cancellation DOT&PF found no reason to participate further in the appeal before the Board of Adjustment; and

WHEREAS, by letter dated May 16, 2016, DOT&PF confirmed its withdrawal from participation in the project; and

WHEREAS, after public notice and notice to the parties, the Board of Adjustment met on May 18, 2016 to consider the status of this appeal;

NOW, THEREFORE, IT IS

RESOLVED that the Board of Adjustment FINDS that by virtue of the State of Alaska, Department of Transportation and Public Facility (DOT&PF) letters dated April 26, 2016 and May 16, 2016, the application dated May 27, 2015 filed by DOT&PF for transportation project site plan review for a new roadway through the U-Med District is deemed withdrawn; and it is

RESOLVED that the Board of Adjustment CONCLUDES there is no case or controversy upon which the Board of Adjustment can render a decision on the merits because the actions of DOT&PF have rendered the appeal of Planning and Zoning Commission Case No. 2015-0057 moot; and it is

RESOLVED that the dismissal of the appeal is to be without prejudice, and that in the event DOT&PF's site plan review application of May 27, 2015 is revived without the requirement of the filing of a new application, Appellant shall be notified and shall have full opportunity to reinstate its appeal; and it is

RESOLVED, that an Order of Dismissal shall be entered accordingly.

<u>ORDER</u>

This appeal is <u>DISMISSED WITHOUT PREJUDICE</u>. In the event DOT&PF's application of May 27, 2015, for transportation project site plan review for a new roadway through the U-Med District is revived without the requirement of a new application, Appellant shall be notified and shall have full opportunity to reinstate its appeal.
