## Application to Vote by Email Instructions and Information

- ▶ **When completing your application be sure to:**
  - **Type or print legibly and use dark ink if you complete the application by hand.**
  - **Provide your complete Municipality of Anchorage residence address.** Your application *will not be processed* if the residence address is left blank or incomplete, or if you submit a PO Box, PSC Box, commercial address, or mail stop.
    - **If your Anchorage residence address has changed**, provide your new address on the application. **This will not update your voter registration.**
  - **Provide a telephone number** where we can contact you.
  - **Provide the email address** where you want to receive your ballot package.
  - **Provide at least one identifier** such as voter number, last four digits of your social security number, or date of birth. This information is kept confidential.
  - **Print** a copy of your application if you are completing it electronically.
  - **Provide your dated handwritten signature.** **A computer generated (electronic) signature is not acceptable.**
  - **Hand-deliver, mail, fax, or scan and email completed application to MOA Elections or the Municipal Clerk's Office.**

**Applications will be accepted beginning January 2019, and voters are encouraged to submit their applications by March 1, 2019.**

- ▶ **Apply early to receive your ballot at an email address.** Completed applications will be accepted beginning January 2, 2019 and must be received no later than 5:00 pm AKDT on **March 26, 2019**. Applications received after 5:00 pm AKDT on **March 26, 2019** will be processed subject to availability of staff and resources until 5:00 pm AKDT on **Monday, April 1, 2019**.
- ▶ Ballot packages will be emailed in the order that applications are received beginning the week of March 25, 2019. **If you do not receive your ballot by 5:00 pm AKDT on Monday, April 1, 2019, call 907-243-VOTE (8683) to obtain a replacement ballot.**
- ▶ **Return your ballot as soon as possible.** Voted ballots must be received by 8:00 pm AKDT on Election Day Tuesday, April 2, 2019.
