Application to Vote at a Temporary Address - Instructions and Information

- o Type or print legibly and use dark ink.
- Provide your complete Municipality of Anchorage residence address. Your application will not be processed if the residence address is left blank, incomplete, or if you submit a PO Box, PSC Box, commercial address, or mail stop.
 - If your Anchorage residence address has changed, provide your <u>new address</u> on the application.
 This will not update your voter registration.
- o Provide a telephone number and/or email address, so we can contact you if necessary.
- o Provide the temporary mailing address where you want to receive your ballot package.
- Provide at least one identifier: voter number, last four digits of your social security number, or date of birth. This information is kept confidential.
- Provide your handwritten signature and date. A computer generated (electronic) signature is not acceptable.
- Hand-deliver, mail, fax, or email completed application to MOA Elections or the Municipal Clerk's Office:

- Apply early to receive your ballot package at a temporary mailing address. Completed applications
 must be received no later than 5:00 p.m. AKDT on June 14.
- Ballot packages will be mailed no later than May 31.
 - If your application is submitted by May 20, then your ballot package will be mailed to your temporary address no later than May 31.
 - If your application is submitted between May 21 and June 14, a replacement ballot package will be mailed to your temporary address.
 - If you have not received your ballot package at your temporary address by June 7 (having submitted your application prior to May 20) or within 7 days of submitting your application after May 21, call 907-243-VOTE (8683) or email elections@anchorageak.gov to learn about other options for you to vote, such as by email, by fax, or in-person.
- Return your voted ballot as soon as possible. Voted ballots must be postmarked no later than Election Day, June 21, 2022, and received by the Clerk's Office by the start of the Public Session of Canvass.

If you will not be available to receive mail at a mailing address between May 31 and June 20, please email <u>elections@anchorageak.gov</u> or call 907-243-VOTE (8683) as soon as possible to learn about other options for you to vote.
