## Application to Vote at a Temporary Address - Instructions and Information

- o Type or print legibly and use dark ink.
- Provide your complete Municipality of Anchorage residence address. Your application will not be processed if the residence address is left blank, incomplete, or if you submit a PO Box, PSC Box, commercial address, or mail stop.
  - If your Anchorage residence address has changed, provide your <u>new address</u> on the application.
     This will not update your voter registration.
- o Provide a telephone number and/or email address, so we can contact you if necessary.
- Provide the temporary mailing address where you want to receive your ballot package.
- Provide at least one identifier: voter number, last four digits of your social security number, or date of birth. This information is kept confidential.
- o Provide your handwritten signature and date.
- Hand-deliver, mail, fax, or email completed application to MOA Elections or the Municipal Clerk's Office:

- Apply early to receive your ballot package at a temporary mailing address. Completed applications
  must be received no later than 5:00 p.m. AKDT on March 31.
- Ballot packages will be mailed out beginning March 17.
  - If your application is submitted by March 16, then your ballot package will be mailed to your temporary address beginning March 17.
  - If your application is submitted between March 17 and March 31, a replacement ballot package will be mailed to your temporary address.
  - If you have not received your ballot package at your temporary address by March 25 (having submitted your application prior to March 16) or within 7 days of submitting your application after March 17, call 907-243-VOTE (8683) or email <a href="mailto:elections@anchorageak.gov">elections@anchorageak.gov</a> to learn about other options for you to vote.
- Return your voted ballot as soon as possible. Voted ballots must be <u>postmarked</u> no later than Election Day, April 7, 2026, and received by the MOA Elections by the start of the Public Session of Canvass.

If you will not be available to receive mail at a mailing address between March 17 and April 7, please email <u>elections@anchorageak.gov</u> or call 907-243-VOTE (8683) as soon as possible to learn about other options for you to vote.
